TITLE: Motion to approve a two-year contract for the purchase of sod and sod

installation - Southeast Florida Governmental Purchasing Group (Co-Op)

## Recommendation

It is recommended that the City Commission award a two-year contract to the low responsive and responsible primary and secondary bidders, Sunset Sod, Inc., Tropical Landscaping & Lawn Maintenance, Inc. and Mullings Engineering Services, LLC. Purchases are made on an as needed basis in accordance with Co-Op contract 006-2730-12-GJL in the estimated annual amount of \$162,000 for a total estimated amount of \$324,000, and authorize the City Manager or designee to approve the renewal options contingent upon approval and appropriation of funds.

## **Background**

The Public Works and Parks and Recreation Departments, during the course of utility operations and maintenance activities (such as underground pipe repair and construction, swale reclamation activities, and park maintenance), may disrupt grassy areas. These areas are restored to "original or better" condition with the replacement of sod.

The City of Boynton Beach as lead agency for the Co-Op issued an Invitation to Bid (ITB) for various types of sod and sod installation to 108 firms. Five responses were received. The purpose of this ITB was to contract with two qualified contractors; one as the primary contractor and the second as the secondary contractor to furnish, deliver and install various species of sod by group and by zone. The City of Fort Lauderdale is located in the central zone. The tabulation, Exhibit 1, shows the pricing from each vendor. Exhibit 2 lists each species of sod by group and the primary and secondary vendors that were awarded a Co-Op contract for the central zone.

## **Resource Impact**

There is a fiscal impact to the City in the estimated annual amount of \$162,000 for the purchase of sod and sod installation on an as needed basis depending on funding availability for Public Works and the Parks and Recreation Departments. Future expenditures are contingent upon approval and appropriation of the FY 2014 budget.
