

RESOLUTION NO. 17-07 (CRA)

A RESOLUTION OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY, AMENDING THE COMMUNITY REDEVELOPMENT AGENCY BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016 AND ENDING SEPTEMBER 30, 2017; TRANSFERRING FUNDS BETWEEN CAPITAL PROJECTS AND APPROPRIATING FUND BALANCES; AND PROVIDING FOR AN EFFECTIVE DATE.


WHEREAS, on September 12, 2016 the Fort Lauderdale Community Redevelopment Agency adopted the Final Operating Budget, and Capital Improvement Plan (CIP) Allocations for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE, COMMUNITY REDEVELOPMENT AGENCY:

SECTION 1. That the Final Operating Budget of the Fort Lauderdale Community Redevelopment Agency for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017 is hereby amended by transferring funds between capital projects and appropriating funds as set forth in the Community Redevelopment Agency Agenda Memo #17-0978, copy of which is attached hereto and incorporated herein.

SECTION 2. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution Approving the Appropriation of \$1,350,000 to the Development Incentive Fund

Recommendation

It is recommended that the Community Redevelopment Agency (CRA) Board of Commissioners approve the transfer of \$1,350,000 to the Development Incentive Fund (CRA091704).

Background

On August 22, 2017 the CRA Board of Commissioners approved a \$10 million Development Incentive to the YMCA of South Florida secured by an eight (8) year forgivable mortgage against the property subordinated to the first mortgage lender. The Development Incentive provides funding towards debt service for the construction and development of a \$15 million state of the art community center located within the Northwest-Progresso-Flagler Heights (NFP) CRA's focus area along historic Sistrunk Boulevard. At this same meeting, the CRA Board of Commissioners also approved \$281,274 to All Aboard Florida – Operations, LLC and \$183,820 to FLL Property Ventures, LLC (Brightline) for streetscape improvements associated with the All Aboard Florida Passenger Railway.

The purpose of the budget transfer appropriation is to move enough funds into the Development Incentive Fund to cover the FY 2017 incentive payments for the YMCA (\$1,250,000) and All aboard Florida and Brightline (\$100,000) (See Exhibit 1).

Consistency with the NPF CRA Community Redevelopment Plan

The project is consistent with the NPF CRA Community Redevelopment Plan which identifies Progresso Commercial Revitalization as a comprehensive program to redevelop this largely deteriorated industrial area of the City that has the potential to serve as a major source of investment and employment for the surrounding community. Per the Plan, the CRA will establish incentive programs to address redevelopment obstacles. The CRA 5 Year Program, which is incorporated as part of the Plan, identifies strategic objectives, goals and measurements that include targeting and attracting businesses, retail uses and industries to establish a presence in the redevelopment area and create jobs for area residents. In addition, it calls for investing

in development projects that create job opportunities for area residents, promote public private partnerships and investment in the redevelopment area.

Resource Impact

Funds for this transfer in the amount of \$1,350,000 are available for Fiscal Year 2017.
