TITLE: Motion Approving Agreement for Streetlight Fixtures, Annual Contract -
Electric Supply of Tampa, LLC - \$718,300 - (**Commission Districts 1, 2, 3
and 4**)

Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for streetlight fixtures with Electric Supply of Tampa, LLC, for an initial one (1) year contract term amount of \$718,300; and authorize the City Manager, or designee, to approve three (3), additional one-year renewal options, for an estimated annual amount of \$718,300, and a potential total contract amount of 2,873,200.

Background

The Parks and Recreation Department requires a supply company to purchase replacement parts in order to maintain current street light fixtures and to replace outdated high pressure sodium (HPS) fixtures that are still in place in some areas. This contract also includes smart nodes for tracking light outages and failures as well as Florida Fish and Wildlife Commission (FWC) approved amber street light fixtures that can be used along A1A on the barrier island.

On June 15, 2023, the Procurement Services Division issued Solicitation Event No. 111-4 for Streetlight Fixtures, Annual Contract, which opened on July 14, 2023. A total of five (5) responses were received.

All bids were reviewed for compliance with the solicitation specifications. One (1) vendor, Rexel USA Inc., submitted a pricing error and was unable to honor the incorrect price. The bid submitted by Electric Supply of Tampa, LLC has met all of the solicitation requirements and deemed the low responsive, and responsible bid.
