Commissioner Glassman provided background information regarding the Annie Beck House (House), which is owned by the Broward Trust for Historic Preservation (Trust). Commissioner Glassman explained that the City relocated the House to its current location in Middle River Terrace, which has led to improved neighborhood safety in recent years.

Interim City Attorney Spence provided additional background information regarding the lease mandating the House serves as a residence for law enforcement for the purpose of deterring crime.

Commissioner Glassman confirmed the City's significant investments in the House and suggested greater financial participation by the Trust for repairs and maintenance or reconsideration of ownership.

Mayor Trantalis noted that this Agenda item does not specifically address Commissioner Glassman's recommendations and suggested that Commissioner Glassman speak with City Manager Williams. Commissioner Glassman requested the Commission discuss this topic further.

City Manager Williams confirmed the ability to explore amending the lease to balance maintenance obligations. Further comment and discussion ensued regarding options, including transferring ownership of the House to the City.

In response to Commissioner Beasley-Pittman's question, Commissioner Glassman clarified the background information and confirmed a Police Officer has been living in the House for the past seven (7) years. Interim City Attorney Spence expounded on related information.

Mayor Trantalis remarked on the City's financial contribution toward improvements and maintenance of the House.

Commissioner Glassman made a motion to approve this Agenda item and was seconded by Commissioner Sorensen.

Mayor Trantalis raised cautionary concerns regarding this Agenda item and noted the need for heightened Commission scrutiny because the Live Local Act significantly limits the Commission's discretionary authority over what could be built once development rights are granted. He expressed concerns related to authorizing a lease extension without clarity on the proposed development and remarked on the site location within the Himmarshee District and along the Riverwalk.

Mayor Trantalis indicated his willingness to support the resolution, which only sets a public hearing and urged the Commission to carefully consider the long-term implications.

Commissioner Glassman concurred with Mayor Trantalis' comments and requested that staff provide notice earlier in the process when this type of Agenda item impacting District 2 is coming before the Commission. Commissioner Glassman remarked on related Commission action in 2024 and expounded on his perspective.

Commissioner Glassman introduced this Resolution which was read by title only.

Interim City Attorney Spence explained pertinent information regarding this Agenda item.

In response to Commissioner Sorensen's question regarding guidance on this Agenda item, Mayor Trantalis emphasized the importance of delivering a City Hall building that reflects Fort Lauderdale's identity, ambition, and long-term vision that is reflected in the FTL City Hall Partners proposal. Mayor Trantalis expounded on his perspective and confirmed his confidence that the FTL City Hall Partners premium cost could be addressed through reducing overall square footage, refining programming needs, and applying value engineering while maintaining the integrity of the design.

Mayor Trantalis said that his number one (1) ranked proposal is FTL City Hall Partners and his number two (2) ranked proposal is Balfour Beatty.

Commissioner Glassman commented on his viewpoint that all four (4) teams were highly qualified. He pointed out that the two (2) primary distinguishing factors are the Internal Rate of Return (IRR)/bid amount and indirect construction costs and noted that these are the two (2) metrics which teams can be held accountable. Commissioner Glassman said that the Commission's role at this stage is to select the right long-term partner, highlighted the importance of experience, and expounded on his perspective.

Vice Mayor Herbst explained that he could not support the current procurement strategy, recommended rejecting all proposals, and issuing a new solicitation. Vice Mayor Herbst noted his consistent advocacy for a bifurcated City Hall with a ceremonial City Hall in downtown and staff operations that do not interact with the public at an existing property on Cypress Creek Road.

Vice Mayor Herbst discussed his secondary preference to construct a new City Hall adjacent to the new Police Department Headquarters, which would create a consolidated government campus. Further comment and discussion ensued.

Mayor Trantalis remarked on past and future opportunities for public engagement on this topic and noted the Infrastructure Task Force Advisory Committee's recommendation for a P3 approach. Further comment and discussion ensued.

Commissioner Beasley-Pittman confirmed the need for Strategic Communications to ensure the public is consistently informed and engaged in this process going forward.

Commissioner Sorensen introduced this Resolution to proceed with the unsolicited proposal submitted by FTL City Hall Partners as the first ranked proposal, Balfour Beatty as the second ranked proposal, Fort Lauderdale Civic Partners as the third ranked proposal, and FTL Beacon collaborative as the fourth ranked proposal which was read by title only.
