TITLE: Motion Approving Agreement for Hendricks Isle Seawall Replacement –
Ebsary Foundation Co. – \$1,471,590 - (**Commission District 2**)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Hendricks Isle Seawall Replacement Project with Ebsary Foundation Co. in the amount of \$1,471,590.

Background

The purpose of proposed project is to replace two (2) seawalls located on the northern end of Hendricks Isle. The existing seawalls are 260 and 60 linear feet, for a total of 320 linear feet. The new seawalls will be constructed with new sheet-pile and a new concrete cap. Additionally, new stormwater infrastructure, pavement and landscaping restoration will be constructed to drain the runoff from the Hendricks Isle roadway through the new seawall into the adjacent canal.

On December 28, 2021, the Procurement Services Division issued Invitation to Bid No. 12621-923. The City received the following four (4) bids in response to the solicitation, which were opened on February 1, 2022:

1. David Mancini and Sons, Inc.
2. Ebsary Foundation Co.
3. Kelly Brothers, Inc.
4. Poseidon Dredge & Marine, Inc

All bids were reviewed for compliance with the solicitation specifications and none of the four (4) vendors listed their status as a Disadvantaged Business Enterprise (DBE). The bid submitted by Ebsary Foundation Co. has met all of the solicitation requirements and deemed the lowest cost, responsive, and responsible bid.

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,471,590 for the contract award with allowances included; and, \$350,000 for estimated in-house and consultant project

management fees for a total of \$1,821,590. Funds for proposed project in the amount of \$1,821,590 are available in the FY 2022 Community Investment Plan in the accounts listed below.
