Many point to Dr. Bill Kent's decision to transition Team Horner to employee ownership in 2016 as his

defining legacy. Yet, the true heart of his impact lies in the vibrant Team Culture he has cultivated for more than five decades—and continues to reinforce every day. It was this deeply rooted culture that convinced him that turning the company over entirely to its Team was the most thoughtful and sustainable path forward. Dr. Kent has long championed the idea that everyone should share in the company's achievements, a belief reflected in discretionary profit-sharing bonuses, 401(k) matching, and ongoing profit-sharing contributions. His philosophy of collaboration and collective success reaches far beyond the workplace and into the broader community. To expand this spirit of giving, he founded the Bill Kent Family Foundation, which has already supported more than 40 charitable organizations, including the Marian Center for special needs children—a cause that has been close to his heart for decades. The foundation has also matched donations to fund nearly 200 college scholarships for employees' children. Dr. Kent's legacy is fundamentally one of unity, generosity, and the desire to create meaningful change. His actions embody the very essence of Team Horner's mission: "Working Together...Growing Together...Winning Together."

Bill Kent, a Cincinnati native, holds a degree in Physics, an M.B.A., and earned his Doctorate in Global Business in 2015. Throughout his long career, he has taken on numerous national and state leadership roles, including serving as National President of the Pool & Hot Tub Alliance (1996), President of the Florida Swimming Pool Association (1975–1978), President of the National Swimming Pool Foundation (2003–2006), and Chairman of the Board for the International Swimming Hall of Fame (2017–2024). Under his guidance, Team Horner Group transitioned to a 100% employee-owned company, an achievement that helped earn the organization the American Psychological Association's 2016 national award for a "Psychologically Healthy Workplace." Kal Gajraj, PhD is a visionary marketing and community leader whose work has helped reshape how Fort Lauderdale shows up for public health and the arts. As Senior Vice President & Chief Marketing Officer at CAN Community Health, a national nonprofit public health organization with a major presence in Broward County, Kal has used his platform to bring world-class cultural experiences to our city while centering compassion, inclusion, and access to care.

Under Kal's leadership, CAN Community Health has deepened its footprint and visibility in Fort Lauderdale,

connecting residents to HIV testing, prevention (including PrEP and PEP), primary care, and wraparound services regardless of ability to pay. He has championed “Empowering Wellness” as more than a tagline, it is a promise that everyone in our community deserves dignified, affirming healthcare. Kal is known for building partnerships across clinics, nonprofits, government agencies, and tourism organizations to ensure that public health and economic vitality move hand-in-hand.

Kal’s volunteerism also extends into service on boards and advisory roles, where he offers his expertise in marketing, storytelling, and community engagement to strengthen mission-driven organizations. His leadership style is hands-on: he is as likely to be found strategizing with executives as he is welcoming guests at the door, thanking volunteers, or standing backstage making sure each performer feels valued.

Kal frequently collaborates with local coalitions, HIV planning bodies, and nonprofit partners to align messaging, reduce stigma, and ensure that those most impacted by HIV know where to turn for care. He has helped position CAN Community Health as a trusted partner at community events, health fairs, and pride celebrations across Greater Fort Lauderdale.

One of Kal’s most significant contributions to the City of Fort Lauderdale is the inaugural World AIDS Day Concert, presented by CAN Community Health and ViiV Healthcare, which he conceived and produced. Recognizing that Broward County has one of the highest rates of HIV in the nation, Kal set out to create an event that was not just a memorial, but a rallying point for hope, visibility, and action.

Attendees and community leaders consistently described the evening as “transformative,” “deeply moving,” and a turning point in how Broward shows up for World AIDS Day. When national leaders signaled retreat on World AIDS Day recognition, Kal’s response was to bring the community together more boldly, putting Fort Lauderdale on the map as a place where public health, the arts, and social justice intersect on a grand stage.

Kal Gajraj is a nationally recognized marketing executive, community advocate, and arts champion who serves as Senior Vice President & Chief Marketing Officer at CAN Community Health, one of the nation’s largest nonprofit providers of HIV care, prevention, and LGBTQ+ health services. A strategist known for blending creativity with mission-driven impact, Kal leads the organization’s national brand, communications, digital strategy, community engagement, and philanthropic marketing initiatives across multiple states.

Guided by CAN’s promise of Empowering Wellness, Kal has transformed how the organization connects with communities—elevating visibility, expanding partnerships, and positioning CAN as a leader in compassionate, culturally affirming care. His work has strengthened patient engagement, fueled growth across clinic networks, and brought renewed attention to the value of equitable, community-centered public health.

Kal is also the producer behind several high-impact cultural initiatives, most notably CAN’s inaugural World AIDS Day Concert in Fort Lauderdale featuring original RENT stars Adam Pascal and Anthony Rapp. This groundbreaking event brought national attention to Broward County’s HIV response, united local service organizations, and affirmed the power of the arts to drive awareness, healing, and advocacy. His leadership

in this space reflects his deep belief that storytelling, visibility, and shared experiences are essential to ending the HIV epidemic.

A scholar-practitioner, Kal is completing his PhD in Ethical Leadership at St. Thomas University, where his research focuses on diversity, equity, inclusion, and generational leadership in organizational culture. He also serves on advisory boards, mentors emerging leaders, and teaches marketing as an adjunct professor, sharing his expertise at the intersection of ethics, communication, and community impact.

Kal's work has earned recognition from South Florida Business & Wealth, the Communicator Awards, the Stevie Awards, and the Telly Awards. Born and raised in Fort Lauderdale, Native Realty CEO Jaime Sturgis has spent his life and career championing the city that shaped him. His dedication to Fort Lauderdale is not merely professional, it is deeply personal. Now raising his own family in the same community that inspired his early passion for real estate, Jaime has made it his mission to help Fort Lauderdale realize its full potential and ensure that future generations inherit a city thriving with opportunity, creativity and civic pride.

From a young age, Jaime was captivated by the inner workings of real estate. He grew up in Fort Lauderdale watching his father manage and lease retail shopping centers and was fascinated by the craft of attracting

the right tenants, negotiating leases and curating a harmonious mix of businesses. This early immersion instilled in him a deep appreciation for how thoughtful development could elevate a neighborhood and enhance community life.

Jaime carried this passion into higher education, graduating cum laude from Florida State University with a triple major in Real Estate, Entrepreneurship and Professional Sales. His professional journey began in the emerging neighborhoods of Miami during the challenging post-recession years. These areas - Wynwood among them - were still unproven and often gritty. In an environment where gunshots occasionally interrupted property tours, Jaime learned to adapt, innovate and trust his instincts. Those experiences forged his resilience and sharpened the skill set that would later transform Fort Lauderdale's urban core. After establishing himself in Miami's most dynamic transitioning districts, Jaime returned home to Fort Lauderdale with a clear purpose: to help his native city grow into the dynamic, world-class community he knew it could be. In 2017, he made a bold decision to leave a successful position at a major brokerage and launch his own firm, Native Realty, in his twenties. Building the brokerage from scratch, Jaime became not only its CEO but also its lead producer, guiding its ethical standards while simultaneously acting as broker, developer, contractor, property manager and community advocate.

Jaime quickly recognized the underappreciated potential of Flagler Village, then a collection of aging warehouses and neglected properties. Drawing from his experience in Miami's emerging neighborhoods, he envisioned a district alive with creative offices, retail, destination restaurants, art galleries and performance spaces. Through tireless grassroots work and visionary placemaking, he completed more than 2 million square feet of transactions in Flagler Village within five years, helping catalyze an extraordinary transformation.

A milestone moment came in 2019, when Jaime brokered the record-setting \$13.25 million sale of Flagler Uptown and The Hive - two properties he had personally reimaged through extensive renovation, experiential tenant curation and the addition of striking murals by acclaimed artist Herbert Galarza. These transactions not only set price records but also solidified Flagler Village as a creative and cultural hub, drawing institutional investment and contributing to Fort Lauderdale's reputation as a vibrant urban destination.

The success of Flagler Village was just the beginning. Jaime and his team at Native Realty have since applied their proven model to other Fort Lauderdale neighborhoods, including the historic Sistrunk corridor and the evolving Studio City district. Operating with a pioneering, boots-on-the-ground approach, Native Realty has redefined what it means to be a commercial brokerage, focusing not on isolated transactions but on comprehensive neighborhood revitalization. This approach has created lasting economic impact, fostered local entrepreneurship and helped build community identity across Greater Fort Lauderdale.

In 2025, Native Realty surpassed \$1 billion in total transactional volume, closing out a record year that reflects Jaime's unwavering commitment to elevating his hometown. His placemaking contributions have become cornerstone elements of Fort Lauderdale's continued growth and attractiveness to residents, businesses, investors and visitors alike.

Beyond his achievements in real estate, Jaime is deeply committed to civic service and community betterment. Stephen Fallon is the Founding Executive Director of Latinos Salud, a nonprofit established in 2008 that has served Fort Lauderdale and South Florida for over 17 years under his leadership. Latinos Salud operates four full-time locations and provides free, culturally competent health services including HIV and STD rapid testing, PrEP initiation and navigation, vaccinations, Ryan White case management, linkage to medical care, and other preventive services to uninsured and underinsured residents. Annually, the organization conducts over 23,000 HIV tests, 34,000 STD screenings, treats more than 3,000 STD cases, initiates about 2,000 people on PrEP and maintains another 2,000 on PrEP, vaccinates over 1,000 community members,

and stages more than 100 health-and-culture community events that bring residents together for social connection and wellness education. These services directly contribute to improving health outcomes, reducing disease spread, and offering practical support for youth, LGBTQ+, and underserved populations in Broward and Miami-Dade counties.

Under Stephen's direction, Latinos Salud also hosts free community events—such as kayak outings, cultural gatherings, and educational workshops—that foster social support and inclusion, helping young people and adults alike build community networks and resilience. Through fundraising activities, participation in regional efforts like the Fort Lauderdale AIDS Walk, and effective grant stewardship, Stephen has secured the organizational capacity to sustain and grow these services. By making healthcare accessible and welcoming to all identities and backgrounds, his work has enhanced Fort Lauderdale's quality of life and strengthened community cohesion.

2) Describe Linda Carter's accomplishments or contributions to the community, paying particular attention to the criteria with examples.

Linda B. Carter's career represents one of the most consequential and sustained civic contributions in Fort Lauderdale's history. A Broward County native born at Broward General Hospital and raised in Fort Lauderdale, Linda devoted more than four decades to building permanent institutions that strengthen youth, families, nonprofits, and the overall quality of life in the city and region.

Her early career set the foundation for this impact. Over 15 years at what was then the Discovery Center later transformed into the Museum of Discovery and Science Linda rose to Executive Vice President and played a pivotal role in growing the institution into a regional landmark that educates, inspires, and attracts families and visitors to Fort Lauderdale. She raised the funds to move the Museum into its current state-of-the-art facility. This work directly enhanced the city as a place to **live, work, play, and visit**, and established her reputation as an exceptional institution builder.

Linda's most far-reaching contributions came during her 23-year tenure as President and CEO of the Community Foundation of Broward (CFB). When she assumed leadership in 1997, the Foundation held \$20 million in assets and distributed approximately \$1 million annually in grants. Under her stewardship, assets grew to more than \$220 million, and grantmaking expanded to \$1 million per month funding initiatives that profoundly improved outcomes for youth, families, and vulnerable populations across Fort Lauderdale and Broward County.

In providing a **positive outlook for youth**, Linda championed education reform through long-term investments in middle school success, contributing to district-wide improvements that raised graduation rates from 77% to 86%. She also led **foster care** reform by shining a spotlight on youth aging out of care an issue previously lacking advocates and building a coordinated public-private safety net connecting more than eight hundred youth annually to housing, education, employment, transportation, and life coaching.

Linda made equally transformative contributions to **public health and quality of life**, leading the Community Foundation to become the first private funder in Broward to address HIV/AIDS prevention. Over two decades, this work dramatically increased testing and awareness, helped reduce infection rates among newborns, and attracted \$3.7 million for localized prevention solutions. She also originated **Broward Cares** focused on recovery and rebuilding efforts during a crisis. This first of its kind collaboration with United Way of Broward and the Jewish Federation of Broward County. This unique disaster recovery collaborative was later replicated in other parts of Florida.

By fostering collaboration among nonprofits, public agencies, and funders, Linda consistently **strengthened the spirit of the community**. Her leadership development programs enhanced the productivity of more than 11,000 nonprofit staff and board leaders, while her advocacy helped reauthorize the Children's Services Council producing \$60 million annually to address children's issues critical to Fort Lauderdale's future.

Nationally, Linda brought **positive recognition to Fort Lauderdale**, making the Community Foundation of Broward the first in Florida accredited under the National Standards for U.S. Community Foundations and securing its position among the Top 100 community foundations nationwide. Her courageous leadership also established one of Florida's first LGBT Funds, advancing inclusion and diversity and positioning the region as a compassionate, forward-thinking community. Investments of \$8 million enhanced major LGBT serving agencies with infrastructure capacity growth and program development. During her tenure, CFB was among the top 5 LGBT community Funders in the nation.

Other remarkable accomplishments under Linda Carter's CFB leadership for **providing a positive outlook for the future of our youth**:

- Seventy-five percent of D and F middle school students, enrolled in Foundation supported programs, increased their math and reading scores due to long-term commitment to move the needle in education. The School District embraced middle school strategies as a critical fork in the road to drive graduation rate to 90% target.

Other remarkable accomplishments under Linda Carter's CFB leadership for **contributing to the quality of life for our citizens**:

- Stimulated 10,000 hours of cutting-edge volunteerism to capitalize on the talent of newly retired baby boomers. This four-year initiative, "*Re-engage for Good*" produced new strategies that are now embedded in organizations to engage this talent in new ways.

- More than \$6 million in pandemic response were provided – pivoting to provide support for residents’ emergency needs and also investing in long-term solutions for the far-reaching effects of the crisis.
- The Community Foundation’s “*Silver Tsunami*” report on the plight of vulnerable seniors has become a “go to” reference for leaders. State legislators, judges, senior service providers continue to cite this report as their call to action for change and it caused the creation of the first of its kind, Aging Funders Collaborative.
- **Leadership** programs enhanced the productivity of more than 11,000 nonprofit staff and board leaders over 20 years - Increased productivity of 11,000 nonprofit staff and Board leaders producing high-performing organizations. This Leadership program was the first of its kind in Broward and the state and was one of CFB’s signature programs for 20 years.
- Linda Carter has empowered local philanthropists to create personalized charitable funds at the Community Foundation that have distributed more than \$120 million and produced game-changing impact on the issues that matter in our community. Her laser-like focus on building an endowment, means that this support will ALWAYS be there for our community, in perpetuity, for generations to come.

Other remarkable accomplishments under Linda Carter’s CFB leadership in **bringing positive recognition to the City, locally or nationally:**

- CFB has been ranked in top one hundred community foundations in the nation due to growth of size and impact and have remained there for the past 6 years
- CFB is the largest private, local funder of cancer clinical trials in Broward. This work has allowed local hospitals to receive NCI designation as a world class research institution.
- As a result of her work, the Community Foundation became one of the top 5 LGBT community foundation Funders in the nation. The Foundation awarded more than \$8.4 million to support over five hundred programs benefitting LGBT neighbors

Other remarkable accomplishments under Linda Carter’s CFB leadership in **making Fort Lauderdale a place to live, work, or play:**

- Launched the BE BOLD Leadership Campaign, which raised more than \$415 million to grow an endowment able to keep pace with fast-growing community needs.
- For 2024, Community Foundation of Broward managed over \$300M in total assets representing 571 charitable funds and has produced 1,275 individual grants totaling \$20M.
- Linda oversaw the growth of the CFB’s Legacy Society and Community Builders (\$1M+ donors/fund holders), achieving signed promises/confirmed commitments of \$463 million in total planned/estate gifts to the Foundation, this is prodigious because these represent a pipeline of gifts that will be realized over time – and will become endowed funds that will enable the Foundation to invest an additional \$23 million in the community EVERY YEAR....forever.

Through these achievements, Linda Carter has helped make Fort Lauderdale a thriving destination, one known for strong institutions, inclusive values, civic leadership, and long-term investment in people and place.

3) – Why is Linda deserving of this award?

Linda B. Carter deserves the Fort Lauderdale Walk of Fame because her life’s work exemplifies visionary leadership, measurable impact, and lifelong dedication to her hometown.

Unlike many leaders whose contributions are programmatic or short-term, Linda built **permanent civic infrastructure** endowments, institutions, and collaborative systems designed to serve Fort Lauderdale “today and forever.” She transformed organizations that were once little known into indispensable cornerstones of the community, ensuring they would endure through economic cycles and leadership transitions.

Her leadership consistently filled advocacy gaps, addressing complex and sometimes unpopular issues foster care reform, HIV/AIDS prevention, LGBTQ inclusion, education equity, and aging long before they gained broad public attention. These efforts improved lives, influenced public policy, and elevated Fort Lauderdale’s reputation locally and nationally.

Linda’s impact is also deeply personal and place based. Born and raised in Fort Lauderdale, she invested her professional life in strengthening the very community that shaped her. Upon her retirement, the City of Fort Lauderdale proclaimed September 15 as “Linda Carter Day,” recognizing her extraordinary service. Her continued leadership on local, state, and national boards underscores that her commitment to Fort Lauderdale did not end with retirement.

For her courage, vision, institutional legacy, and unwavering dedication to making Fort Lauderdale a better place to live, work, and visit, Linda Carter is a singularly worthy Walk of Fame honoree.

Linda B. Carter is a transformative civic and philanthropic leader and a native of Fort Lauderdale. She earned her degree in advertising from the University of Florida and returned home to begin a distinguished nonprofit career spanning more than 40 years.

Linda spent 15 years with the Museum of Discovery and Science, rising to Executive Vice President and helping grow the institution from the Discovery Center into one of South Florida’s most important cultural and educational attractions.

From 1997 to 2020, she served as President and CEO of the Community Foundation of Broward, where she led its evolution from a \$20 million organization into a nationally recognized

foundation with more than \$220 million in assets and a powerful record of community impact. Under her leadership, the Foundation became the first in Florida to achieve National Standards accreditation and earned consistent placement among the Top 100 community foundations in the United States.

Following her retirement, Linda has held numerous leadership roles, including Vice-Chairman of the Board of Florida House on Capitol Hill; Chair of the Philanthropy Committee and member of the Strategic Planning Committee for Holy Cross Health; and Board Member and former Secretary of Funding Arts Broward. Her past service includes boards such as the Urban League of Broward County, Broward Workshop, Jack and Jill Children's Center, Junior League of Greater Fort Lauderdale, and national philanthropic associations. She continues to lead by example as both a Fundholder and a Legacy Society member at the Community Foundation. This ensures that her own endowed charitable fund will continue to support the needs of Broward County forever.

Preface:

My life went through a tumultuous 2024; my Dad passed away, my fiancée and I had an egregious ending of a six year relationship, and my engineering practice was struggling. Entering 2025 was unpleasant. I needed a change. I met Mr. Jorg Hruschka.

What I learned from Jorg is more profound than offering myself for community services. He opened my eyes to what is truly defined as *community*, his knowledge of our City, and most importantly, offering yourself to the community is rewarding (actually, it's fun).

I am not, by nature, an altruistic man. While I display empathy and sympathy for those less fortunate, it has been my misconception that those in need will, over time, overcome on their own. Then I met Jorg.

Completely misinformed and unaware that the *less fortunate* population experiences generational trauma stemming from chronic poverty, lack of resources, and unstable environments that create a cycle of financial strain, anxiety, and behavioral patterns passed through generations. I had no knowledge nor an up-close-and-personal experience that being raised in low-income families creates stress for generations. I was clueless that a child raised in a low-income family had a significantly increased probability in trauma from instability, neglect, or violence—which often results in a continued inability to escape poverty as adults.

Again, then I met Jorg.

My Experience with Jorg:

Along my journey in seeking out something and someone that could help me recapture my personal focus, I found Jorg on-line and called his office. In my typical manner of over explaining (engineer's folly), he stopped me during the phone call and asked me, "can you meet on Saturday at 7:45am *sharp* at the City's parking garage?"

While he didn't fully explain the details of my duties, he was direct and ended the call, "see you Saturday." I thought to myself, oh no! He's going to have me in a chain gang in an orange jumpsuit along the highway.

I showed up early on Saturday morning. Within minutes of my arrival Mr. Hruschka is there, out of his car, and ready.

Jorg, "Good morning, good morning, you must be Marc?"

"Yes, it's nice to meet you. It's Jorg, correct?"

"Yes. Now I need you to start loading up the truck and we're going to..." And just like that! We were hands-on-deck and moving. Keeping up with Jorg is no easy task.

What I quickly learned about Jorg and his interactions within the community. He is well appreciated. I'll go further; he's loved.

The smiling faces, strong handshakes, hugs and accolades for an individual. The admiration bestowed towards him was intoxicating, jubilant and genuine. It was obvious that, everyone knows Jorg! That was satisfying to me and felt incredible.

While he'll be retiring in 2026, I feel blessed to have met him and hope to remain close with him. He's created a volunteer in me for sure.

Mr. Hruschka has touched the lives of thousands of people in the City in his position. "There is no better exercise for the heart than reaching down and lifting people up."

Note¹: Watching Jorg drive in the City. I find it thoroughly impressive and I would often ask him, "how'd we get here?" He'd just smile and tell me, "please Marc, start unloading, we have three more stops today."

Note²: While writing, I've been smiling the entire time and laughing. He makes volunteering fun. I hope that what he's built continues to grow for the City. His efforts are tiring but worth the sweat. Finally, I must add one comedic acknowledgement of his demeanor. The always enthusiastic statement of, "one more thing, one more thing!" His energy is not of a man ready for retirement.

Thank you, Jorg. I sincerely hope the program you've developed continues to grow in the manner you've established, and the best on your retirement.
