#### **Recommendation**

It is recommended that the City Commission adopt a resolution ratifying a Memorandum of Understanding with the Federation of Public Employees, a Division of NFPPE, AFL-CIO, District 1-MEBA (Federation).

### **Background**

Pursuant to the Collective Bargaining Agreement between the City and Federation for the period November 7, 2017 through September 30, 2019, the City and Federation agreed that either party may reopen the agreement to negotiate the findings, recommendations, and conclusions of the City's Classification and Compensation Study. The City and Federation met and agreed to a Memorandum of Understanding, attached hereto as Exhibit 1. A ratification vote is scheduled for November 5, 2018 for all bargaining unit members.

#### **Resource Impact**

There is an estimated impact of \$409,391 associated with changes to the pay grades and management benefits that was approved and appropriated in the Fiscal Year (FY) 2019 Budget. The amounts, by fund, are summarized in the table below:
