TITLE: Motion Approving Increase in Cost Capacity to the Piggyback Agreements

for Traffic Signal Improvements & Repairs – AGC Electric, Inc., AUM Construction Inc., Horsepower Electric Inc., and R & D Electric, Inc. –

\$1,150,000 – (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an increase in contract cost capacity (CAP) to the Piggyback Agreements for Traffic Signal Improvements & Repairs with AGC Electric, Inc., AUM Construction Inc., Horsepower Electric Inc., and R & D Electric, Inc. in an aggregate amount \$1,150,000, increasing the award from \$350,000 to \$1,500,000, effective through the initial period ending June 22, 2026. Additionally, to increase the annual renewal amounts by \$575,000 per year, from \$175,000 to \$750,000, for the two (2) one-year renewal options, for a potential total contract amount of \$3,000,000.

Background

On July 2, 2024, the City Commission awarded the Piggyback Agreements for Traffic Signal Improvements & Repairs, utilizing the City of Miami Beach's Invitation to Bid No. 2023- 057-ND, and resulting contracts with AGC Electric, Inc., AUM Construction Inc., Horsepower Electric Inc., and R & D Electric, Inc. (CAM #24-0598). These agreements were awarded through the initial term ending June 22, 2026 with two (2) one-year options to renew, for a potential total contract term of four (4) years.

The piggyback agreements are contracts with a predetermined scope of work to be performed by the contractor pursuant to the issuance of work orders, specified location, project description, and amount of work required. These agreements provide a means of quickly responding to critical needs on an as-needed basis. When projects are needed, the requesting department will select the awarded vendor that has the best pricing and availability for the entirety of the items/services required on a project-by-project basis.

Due to fiscal year funding constraints at the time of the award, the agreements were initially awarded at \$350,000 with the intention that subsequent CAP increases would follow as funding became available and projects were fully defined. It was intended that 01/07/2025

the Piggyback Agreements for Traffic Signal Improvements & Repairs would have a CAP increase year-to-year as new neighborhood projects, or portions thereof, were funded for design, permitting, and construction.

This CAP increase will allow the City to address items such as traffic and pedestrian signal improvements and repairs, signage, pavement markings, traffic calming elements, asphalt, sidewalk, lighting installation and repair, sod restoration, and ADA access ramp needs within the City.

Resource Impact

There will be a current fiscal year impact on the City in the amount of \$575,000 for this CAP increase. Funds for this increase, in the amount of \$575,000, are available in the accounts listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
