**TITLE:** Motion to award a one-year contract for summer camp food – Volusia  
County Contract 14-B-88PW - \$121,000

---

**Recommendation**

It is recommended that the City Commission award a one-year contract for the purchase of summer camp food to G.A. Food Services of Pinellas County, Inc. in the estimated annual amount of \$121,000 in accordance with Volusia County Contract 14-B-88PW and authorize the City Manager to approve four, one-year renewal options, contingent upon appropriation of funds.

**Background**

The Parks and Recreation Department has been a sponsor with the Summer Food Service Program administered by the Department of Agriculture for the last 25 years. This program allows children living in Fort Lauderdale to access healthy food during the summer months. Eight of the Park and Recreation camp sites which offer the program are open to the public. Anyone under the age of eighteen is eligible for the meals. Lunch cost will be \$2.69 each and snack costs will be \$ .64 each.

Pursuant to Section 2-181(7) of the Code of Ordinances, these purchases will be made in accordance with Volusia County Contract 14-B-88PW from G.A. Food Services of Pinellas County, Inc. in the estimated annual amount of \$121,000, whereby such contract or formal bid followed formal bid procedures of sealed written bids, public opening and legal advertising.

**Resource Impact**

Contingent upon approval of agenda item #14-0634, the consolidated budget amendment, there will be a fiscal impact to the City in the amount of \$121,000. No grant match is required.
