TITLE: Motion Approving Agreement for the Annual Sidewalk, Asphalt, and Paver
Emergency Repair - FG Construction, LLC - \$800,000 - (**Commission
Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for the Annual Sidewalk, Asphalt, and Paver Emergency Repair with FG Construction, LLC, for the initial two year term estimated amount of \$800,000; and authorize the City Manager to approve two, one-year renewal options, in the estimated annual amount of \$400,000, for a potential total contract amount of \$1,600,000, including allowances for equipment rental, dumping fees, permit fees, etc., contingent upon appropriation of funds.

Background

On January 18, 2023, the Procurement Services Division issued an Invitation to Bid Number 12650-633 and did not receive any initial bidders, so the bid was extended to March 30, 2023. The bid submitted by FG Construction, LLC (FG) was reviewed for compliance with the requirements of the bid. FG is deemed the low responsive, and responsible bidder recommended for award. FG did not list its status as a Disadvantaged Business Enterprise (DBE).

This is an on an as-needed basis agreement and the agreement amount is an estimate and not a guarantee of the amount of work that will be assigned to meet the operational needs of the City.

Resource Impact

There will be a fiscal impact to the City in the amount of \$73,260.25 for this award with bid allowances included. Funds for this purchase in the total amount of \$73,260.25 are available in the FY 2023 Operating Budget in the accounts listed below: Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
