### The purpose of this Change Order is:

To address quantity overruns and reductions for this period that were due to multiple transformer relocations based on customer needs, differences between estimated and actual conduit/wire footages and vault/hand hole installations, and additional work necessary due to FPL plan revisions and field conditions.

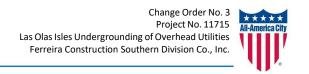
