TITLE: City Attorney Search Update – **(Commission Districts 1, 2, 3, and 4)**

The purpose of this item is to provide an update to the Commission on the City Attorney search being conducted by search firm MGT Impact Solutions, LLC (MGT) in conjunction with the City Attorney Search Committee (Search Committee).

MGT advertised the position from July 23, 2025, to August 22, 2025, and received thirty applications. MGT recommended the following five (5) candidates to the City Attorney Search Committee:

- Paul G. Bangel, Senior Assistant City Attorney, City of Fort Lauderdale
- Alain E. Boileau, Contracted City Attorney for City of Sunny Isles Beach, Nabors, Giblin & Nickerson, P.A.
- Shari L. McCartney, Partner, Tripp Scott, P.A.
- Angela “Angel” Rosenberg, Local Government Attorney, Angel Petti Rosenberg P.A.
- Ronald T. Tomasko, Assistant County Attorney, Collier County

Mr. Alain E. Boileau withdrew prior to the interviews, and the remaining candidates were interviewed by the Search Committee on September 5, 2025. The Search Committee recommends the following candidates for further consideration by the Commission:

- Paul G. Bangel
- Shari L. McCartney
- Angela “Angel” Rosenberg

The Search Committee will present its recommendations at the September 16, 2025, Conference Meeting for the Commission to consider and decide on next steps.
