

RESOLUTION NO. 25-173

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING A FINAL BUDGET OF \$223,168 FOR THE SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT FOR FISCAL YEAR BEGINNING OCTOBER 1, 2025, AND ENDING SEPTEMBER 30, 2026.

WHEREAS, the Board of Directors of the Sunrise Key Neighborhood Improvement District has prepared a budget and has proposed a millage rate for the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2025, and ending September 30, 2026; and

WHEREAS, on September 3, 2025, the City Commission of the City of Fort Lauderdale, Florida, adopted and approved a tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal period beginning October 1, 2025, and ending September 30, 2026; and

WHEREAS, a Notice of Final Millage and Final Budget Hearings has been published as required in Section 200.065, Florida Statutes, advising the public that a public hearing on the final millage rate and final budget would be held on September 12, 2025, at 5:01 P.M. before the City Commission at the Broward Center for the Performing Arts, Mary N. Porter Riverview Ballroom, 201 SW 5th Avenue, Fort Lauderdale, Florida; and

WHEREAS, said public hearing has been held as stated above and comments from the public, if any, concerning said final millage rate and final budget have been heard and considered; and

WHEREAS, the Sunrise Key Neighborhood Improvement District set its millage rate at 1.0000 mill and established its budget of \$199,800 at its May 6, 2025, meeting, and the revenue generated from this millage rate is estimated at \$223,168; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale to adopt a final budget of the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2025, and ending September 30, 2026;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That a budget in the amount of \$223,168 is hereby adopted and approved as the final budget for the Sunrise Key Neighborhood Improvement District for the fiscal period beginning October 1, 2025, and ending September 30, 2026.

SECTION 2. That this resolution will take effect immediately upon its adoption.

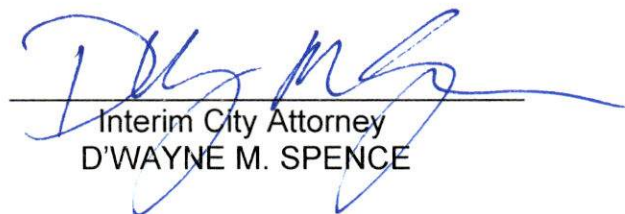
