### FIRST AMENDMENT TO FACILITY USE AGREEMENT

This FIRST AMENDMENT TO FACILITY USE AGREEMENT ("First Amendment") is made and entered into this \_\_\_\_ day of \_\_\_\_\_\_, 2023, by and between CITY OF FORT LAUDERDALE, FLORIDA, a Florida municipal corporation, ("CITY"), whose address is 100 N. Andrews Ave., Fort Lauderdale, Florida 33301, and FLORIDA BEACH BOWL INC., a Florida Not For Profit Corporation ("USER"), whose address is 2045 Biscayne Blvd, Suite 490, Miami, FL 33137.

#### **RECITALS**

WHEREAS, USER seeks to change the date or use non December 28, 2023 to December 13, 2023 at the request of the National Collegiate Athletic Association;

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments hereinafter set forth, the receipt and sufficiency are hereby acknowledged, the CITY and USER agree as follows:

1. The recitations set forth above are true and correct and are incorporated herein. Initial capitalized terms or other such terms used herein shall have the same meaning given such terms in the Lease, unless otherwise defined herein or unless the context otherwise indicates.

### Amendments.

a. Section 2 TERM. of the Facility Use Agreement is hereby amended as follows:

"USER shall have use of the Stadium, on Wednesday, December 13, 2023, subject to the rights, title and interest of MIAMI BECKHAM outlined in the Comprehensive Agreement (the "Period of Use")."

b. Section 4. USE OF THE PREMISES. of the Facility Use Agreement is hereby amended as follows: "USER shall use and occupy the Stadium on Wednesday, December 13, 2023, for the exclusive and limited purpose of hosting a football bowl game between a Historically Black College or University ("HBCU") Bowl Game and a Mid-Major Division 1 football program. The Stadium shall not be used for any other purpose whatsoever without the written consent of the CITY. USER covenants that it will not, without written consent of the CITY, permit the Stadium to be used or occupied by any person, firm, entity, or corporation other than USER and its agents. USER shall not permit the Stadium to be used or occupied in any manner which will violate any laws or regulations of any governmental authority. USER shall not use or authorize the use of the Stadium in any manner which would have a material detrimental impact on the Stadium."

c. Section 10. AUTHORITY OF CITY MANAGER. of the Facility Use Agreement is hereby amended as follows:

"USER shall coordinate the use of the Stadium in accordance with the terms and conditions outlined in this Agreement. The City Manager is hereby authorized to approve a substitute date of use that is a date within 30 days of December 13, 2023, upon receipt of reasonable notice from the USER and in proof of consent from MIAMI BECKHAM. Such substitute date of use shall not be an additional day of use. The City Manager shall notify USER when, in the City Manager's reasonable opinion, such activities may be or are detrimental to the public or to the CITY, or if the CITY has reason to believe that USER, its agents, subcontractors, independent contractors and/or employees have violated any law, rule or ordinance. After consultation with USER, the CITY reserves the right to eject or cause to be ejected from the Stadium any person or persons causing a disturbance and neither the CITY nor any of its officers, agents or employees shall be liable to USER for any damages that may be sustained by USER through the exercise by the CITY of such right. The decision of the City Manager in such regard shall be final and binding."


