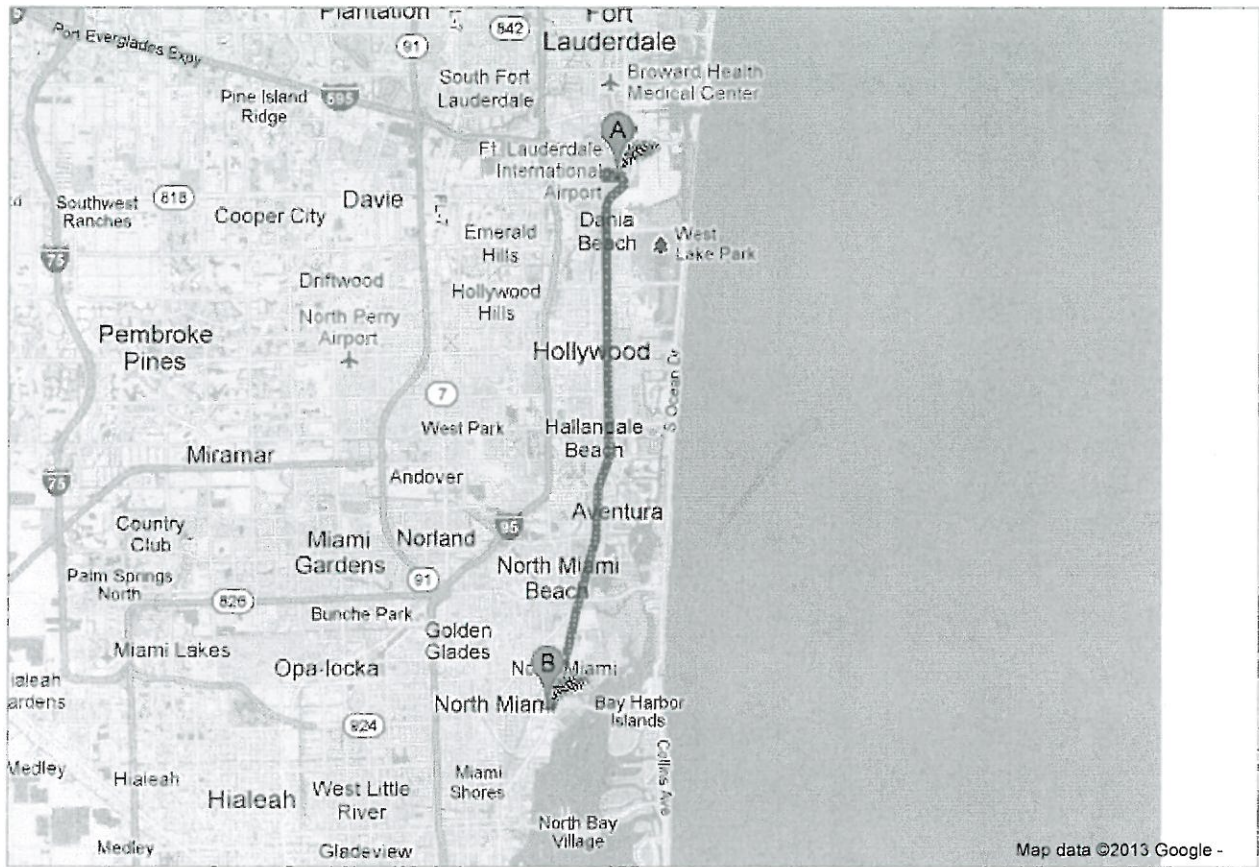

Contract 413-10789 Aggregates, Local was created so the City of Fort Lauderdale would have a local distribution point for items to be picked up. As listed in the bid specifications (see below), this location must be within 10 miles of the City of Fort Lauderdale.
