TITLE: Motion Approving Agreement for Janitorial Services, Recreational Areas -

Image Janitorial Services Inc. - \$425,835 - (Commission Districts 1, 2, 3

and 4)

#### Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for Janitorial Services, Recreational Areas with Image Janitorial Services Inc., for an initial two (2) year term amount of \$425,835; and authorize the City Manager to exercise two (2) options to renew for an additional one year period in the annual renewal amount of \$212,917.50, for a potential total contract amount of \$851,670, contingent upon appropriation of funds.

### **Background**

The Parks and Recreation Department will utilize janitorial services at 25 locations including various City parks, Cooley's Landing, and 15<sup>th</sup> Street Boat Basin. The Contractor will be required to furnish all labor, insurance, uniforms and materials.

On February 27, 2023, the Procurement Services Division issued Request for Proposals (RFP) Event 49-2 - Janitorial Services, Recreational Areas, for the City of Fort Lauderdale.

On March 21, 2023, the event closed and a total of seven (7) firms submitted proposals:

- 305 Multiple SVC, Inc.
- Amer-Plus Janitorial Maintenance LLC
- Clean Space, Inc.
- Image Janitorial Services Inc.
- Kita Corp.
- Onx Management & Trust LLC
- P.C.S. Professional Cleaning Services Corporation

Amer-Plus Janitorial Maintenance LLC and P.C.S. Professional Cleaning Services Corporation listed their status as a Disadvantaged Business Enterprise (DBE).

On May 3, 2023, the Evaluation Committee (Committee) met to evaluate and rank the proposals based on the following criteria:

Evaluation Criteria	Weight (%)
Understanding of the overall needs of the City for such services, as presented in the narrative proposal	20%
Experience, qualifications and past performance of the proposing firm, including persons proposed to provide the services, facilities, resources and references	50%
Total Project Cost	30%
TOTAL PERCENT AVAILABLE:	100%

Proposals were considered and the Committee deemed all firms responsive and responsible, and after initial scoring, it was determined to shortlist Amer-Plus Janitorial Maintenance LLC; Clean Space Inc.; Image Janitorial Services, Inc.; and P.C.S. Professional Cleaning Services Corporation to give oral presentations.

On July 25, 2023, the Committee met to hear presentations from the above-mentioned shortlisted firms. After the presentations, the Committee convened, scored, and confirmed the final rankings.

The Committee determined that Image Janitorial Services, Inc. is the highest ranked, responsive, and responsible firm.

Staff recommends the City Commission approve the award of the Janitorial Services, Recreational Areas procurement and subsequent agreement to Image Janitorial Services, Inc.
