Subject: NE 4th Avenue – City of Fort Lauderdale Grant Application


Dear Ms. Fanchi,

The Florida Department of Transportation (the Department) understands that the City of Fort Lauderdale (the City) is submitting an application for a Broward County Redevelopment Grant to construct features along SR 811/Dixie Highway/NE 4th Avenue between SR 838/Sunrise Boulevard and NE 13th Street. The Department acknowledges that the proposed project is consistent with the vision to further enhance the complete street elements along this state roadway.

The corridor enhancements proposed by the City would be additional to the improvements currently under design by the Department for SR 811 (FPID 431657-1). These plans are approximately 80% complete. This project limits extend from SR 838/Sunrise Boulevard to NE 26th Street. The design phase is estimated to be complete in winter of 2017 and construction is estimated to begin in the summer of 2018. The total estimated project cost of \$5.2 million includes design, construction, and construction inspection services. It is estimated that within the limits from SR 838/Sunrise Boulevard to NE 13th Street, the Department would be spending approximately \$483,000 towards repaving of all lanes, new buffered bike lanes, new crosswalks, retrofitting lighting, ADA improvements, and a new right turn lane at NE 13th Street.

The Department recognizes the City's proposed plan is to enhance this section of SR 811 by providing additional landscape and pedestrian lighting through a separate City project. The City would ultimately need to acquire all the necessary permits to complete the improvements within the Department's right of way. The Department will also review the design prior to approving a permit for construction, with an understanding that the City's design would meet applicable Department criteria and standards. The design and construction oversight of the improvements will be by the City. The City's project would only begin subsequent to the construction of Department's project (FPID 431657-1) is complete. All costs of the subject project by the City would be the responsibility of the City.

The Department looks forward to working with the City to achieve the community's vision through the referenced complete streets improvements. **Purpose:**

This is one of two public information meetings that the Florida Department of Transportation (FDOT) is holding to discuss the State Road 811/NE 4th Avenue/Wilton Drive Complete Streets Project. The project limits are from Sunrise Boulevard to NE 26th Street.

The second public information meeting will be held Wednesday, August 23 at the Hagen Park Community Center, 2020 Wilton Drive, Wilton Manors FL 33305 from 5:30 p.m. to 7:30 p.m.

Improvements to be made:

- Adding buffered bike lanes through the repurposing of one vehicle traffic lane in each direction from Sunrise Boulevard to NE 26th Street
- Improving sidewalks from NE 20th Street to NE 9th Avenue
- Providing landscape opportunity areas from NE 20th Street to NE 9th Avenue
- Upgrading the existing roadway lighting to LED (light-emitting diodes) luminaries
