Grant Purpose

Volunteer Services Network's focus is to harness the talent, expertise and leadership of the 60+, retiring or near-retirement Boomer to engage in a variety of choice volunteer placements. 1) Through the newly created FL 55 Club a natural environment is created for the 60+ community to gather, connect, network the opportunties to volunteer. 2) The Reading Pals, a literacy based program targeting schools with low reading scores in targeted zip codes, is a prime area for over 40 retiring/retired Boomer to mentor 2 hours per week.

Specific Goals/Objectives:

- Targeted 60+ Boomer goal to increase overall to 120.
 Raise the retired Boomer volunteerism stats- 19.9% of population of 55 or over volunteer/ 6.6% engaged in civic activity.
- 20 targeted retired Boomers will facilitate Hands-Only CPR awareness education to over 2,500
- Engage 20 targeted retired Boomers as city ambassadors
- Use 50 of the targeted retired Boomers for educational outreach to 1000 households
- Engage 25 targeted retired Boomers to assist in City departments, with goal of 1000 hours
