RESOLUTION NO. 24-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, RENAMING THE CITY OF FORT LAUDERDALE PARK LOCATED AT 3950 RIVERLAND ROAD, FROM "RIVERLAND WOODS PARK" TO "LAUDERDALE ISLES LANDING"; PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on January 5, 2024, the City of Fort Lauderdale's Parks and Recreation Department received a letter from the Lauderdale Isles Civic Improvement Association, Inc. requesting the renaming of Riverland Woods Park located at 3950 Riverland Road, Fort Lauderdale, Florida, to "Lauderdale Isles Landing"; and

WHEREAS, consistent with the guidelines for Naming Parks, Recreation Areas and Major Facilities Policy adopted by the City Commission, as amended on December 20, 2011, the Parks and Recreation staff evaluated the renaming request and determined that the suggested name has merit for discussion and consideration by the Parks, Recreation and Beaches Advisory Board; and

WHEREAS, notice was provided to surrounding homeowner associations and two Public Notices were placed at the entrance to the Riverland Woods Park and adjacent to the boat ramp informing the residents that the proposed re-naming will be considered by the Parks, Recreation and Beaches Advisory Board at its meeting on January 24, 2024; and

WHEREAS, on January 24, 2024, the Parks, Recreation and Beaches Advisory Board unanimously recommended approval of renaming Riverland Woods Park to "Lauderdale Isles Landing" and instructed staff to forward its recommendation to the City Commission for consideration; and

WHEREAS, the City Commission has considered the renaming request and determined that the suggested name change meets the guidelines for Naming City Parks, Recreation Areas and Major Facilities;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The City Commission for the City of Fort Lauderdale hereby declares the Riverland Woods Park located at 3950 Riverland Road, Fort Lauderdale, Florida, shall be renamed to "Lauderdale Isles Landing".
