A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE TRANSFER OF CITY-OWNED PROPERTY LOCATED AT 1200 NW 3 STREET, IN THE NORTHWEST-PROGRESSO-HEIGHTS COMMUNITY REDEVELOPMENT FLAGLER AREA, AND 1145 NW 5 AVENUE, IN THE CENTRAL CITY COMMUNITY REDEVELOPMENT AREA, TO THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY FOR PUBLIC PURPOSES PURSUANT TO SECTION 8.02 OF THE CITY CHARTER SUBJECT TO TERMS AND THE CONDITIONS: AUTHORIZING PROPER CITY **OFFICIALS** TO **EXECUTE** THE **CONVEYANCE** INSTRUMENTS: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 7, 2024, pursuant to Resolution No. 24-222, the City Commission of the City of Fort Lauderdale declared its intent to convey City-owned parcel located at 1200 NW 3 Street (Folio ID 504204200450) in the Northwest-Progresso-Flagler Heights and City-owned parcel 1145 NW 5 Avenue (Folio ID 494234037570) in the Central City Community Redevelopment Area to the Fort Lauderdale Community Redevelopment Agency; and

WHEREAS, Section 8.02 of the City Charter requires a public hearing on the terms of the proposed transfer and the proposed use; and

WHEREAS, conveyance of the properties, parcel 1200 NW 3 Street (Folio ID 504204200450 and 1145 NW 5 Avenue (Folio ID 494234037570) is for affordable housing purposes; and

WHEREAS, as stipulated in Section 8.02 of the City Charter, the City is authorized to convey real property it owns to another public entity for a public purpose that serves the public interest; and

WHEREAS, the public hearing to receive comments from the public was properly set and noticed for Tuesday, December 17, 2024 at 6:00 pm, or as soon thereafter as can be heard.
