**REVISED PUR-1** -Motion to Approve Contract for Purchase of Crossing

Guard Services – The Butler Group of South Florida, LLC d/b/a NEXTAFF

(Miami) - \$1,865,506

#### Recommendation

It is recommended that the City Commission award a two-year contract, in substantially the form attached, for the purchase of crossing guard services with The Butler Group of South Florida, LLC d/b/a NEXTAFF (Miami) in the amount of \$1,865,506, and authorize the City Manager to approve two one-year renewal options, contingent upon appropriation of funds.

## Background

According to Florida Statute (316.75), crossing guard services must be administered by FDOT certified trainers. It is more advantageous for the City to outsource such services, than to operate an in-house training and certification program. The City's crossing guard program is currently fully funded by parking fine surcharge. There are 18 schools located within the Fort Lauderdale City limits. It is anticipated that 95 school crossing guards will be required for each school day. The crossing guard schedule and complete list of schools where they will be dispatched is included in the Solicitation.

On January 29, 2018, the Procurement Services Division issued Invitation to Bid No. 12102-783 and received six bids. The bid submitted by The Butler Group of South Florida, LLC d/b/a NEXTAFF (Miami) has met all of the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder. Nextaff (Miami)'s bid is only a 1% higher than our current contract, which is with the same company and will be expiring on May 31st 2018.

### Resource Impact

There is a current fiscal year impact in the amount of \$265,650. Future expenditures are contingent upon approval and appropriation of future annual budgets.
