Maite,

Section 5-530, Broward County Ordinance provides "The municipal ordinance shall control the historical sites and structure, and archaeological sites, or both, within the municipality, ***provided the municipality adopted an ordinance protecting historic resources or archaeological sites, and this County ordinance shall not be applicable within the municipality.***" [emphasis added]

The City of Fort Lauderdale Unified Land Development Regulations provides as follows:

"Section 47-24.11.C. Certificate of appropriateness.

1. When permit is required.
  - a. No person may undertake any of the following actions affecting a designated landmark, a **designated landmark site**, or a property in a designated historic district without first obtaining a certificate of appropriateness from the historic preservation board:
    - i. Alteration of an archeological site, or
    - ii. New construction, or
    - iii. Demolition, or
    - iv. Relocation.
    - v. Alteration of the exterior part of a building or a structure or designated interior or portion thereof of a building or structure; however, ordinary repairs and maintenance that are otherwise permitted by law may be undertaken without a certificate of appropriateness, provided this work on a designated landmark, a designated

landmark site, or a property in a designated historic district does not alter the exterior appearance of the building, structure or archeological site, or alter elements significant to its architectural or historic integrity.

- vi. When located within a designated historic district, uses of land such as those including but not limited to, furniture placed outdoors, pushcarts, mobile or non-mobile vending machines and trolley cars placed on private property.
- b. Whenever any alteration, new construction, demolition or relocation is undertaken on a property in a designated historic district without a certificate of appropriateness, the building official shall issue a stop work order.
- c. Review of new construction and alterations to designated buildings and structures shall be limited to exterior features of the structure, except for designated interior portions. Whenever any alteration, new construction, demolition or relocation is undertaken on a designated landmark, a designated landmark site, or buildings or structures within a district without a certificate of appropriateness, the building director shall issue a stop work order.
- d. A certificate of appropriateness shall be a prerequisite and in addition to any other permits required by law. The issuance of a certificate of appropriateness by the board shall not relieve the property owner of the duty to comply with other state and local laws and regulations.”

Note that the section is applicable to Landmark sites, which by definition are:

Section 47-24.11.A

- 13. Landmark site. The land on which a landmark and related buildings and structures are located and the land that provides the grounds, the premises or the setting for the landmark. A landmark site shall include the location of **significant archeological features** or of a historical event, and shall include

all significant trees, landscaping and vegetation as determined by the board.

Therefore the Broward County Ordinance is not applicable within the City of Fort Lauderdale. If you have any questions please do not hesitate to contact me.

Steve, I have to disagree with your position. Section 5-530 of the Code of Ordinances provides for countywide applicability of the ordinance except to the extent that a municipality has an ordinance that preserves historic sites and structures and protects archaeological resources from ground disturbance. My understanding is that the City of Fort Lauderdale ordinances do not address archaeological resources and the County ordinance is applicable.

Please find attached the Historic Preservation Board ("HPB") results from the December 1, 2014 meeting, for the above referenced project. The HPB voted unanimously to approve the application with conditions, adopting the demolition management plan that was drafted by Robert Carr and submitted by the applicant, with the modification that the eight measures to minimize the impact on the archeological deposits be included in the plan, as modified by number eight, providing a weekly report to the Broward County Archeologist and if any significant findings were found on the site, work stoppage should occur immediately and be directed at the area of discovery and the find would be reported to the Broward County Archeologist within 48 hours; work would continue only after approval by the Broward County Archeologist (attached hereto as Exhibit-1016 Waverly Road).

These conditions/stipulations were made without the Broward County Archeologist or representative in attendance. Therefore, I am requesting that you review the attached conditions and let us know if the conditions are acceptable to Broward County and can be monitored by the Broward County Archeologist and notification to the City can be maintained to assure said conditions are met for the Certificate of Appropriateness ("COA") request to demolish the existing house on site.

Also, we are in receipt of your attached letter (DOC120914) received this week regarding the Archeological Discovery at 1016 Waverly Road, FMSF 8BD87. We will respond to said letter in a separate correspondence, once it is reviewed by City staff, including the City Attorney's Office.

Following up with your email below and our conversation this afternoon.

As we discussed, the discoveries made at Rivermont were reported to both the State and County pursuant to F.F. 872.05 as it pertains to discovery of unmarked burials and pursuant to Broward County Ord. No. 2014-32 (formerly Ord. No. 92-38) as it pertains to archaeological discoveries.

The point of contact for this project at the State is Mr. Daniel Seinfeld, Archaeologist with the State Division of Historical Resources. Mr. Seinfeld is seeking input from the Seminole Tribe regarding the consideration of remains. Both Mr. Seinfeld and I have been in touch with Mr. Carr and briefly discussed potential Phase II archaeological work on the property.

Development of the site should be coordinated with Mr. Seinfeld as it has been demonstrated that there is potential for the discovery/disturbance of unmarked burials.

I am reviewing material associated with the discovery and will provide you with additional information when it is available.

We recently began Phase 1 testing at the Rivermont Site in Broward County (8BD87). We completed 15 shovel tests around the house and along one transect, with more shovel testing to follow in the next few weeks. During the review of the recovered material from this first stage, we identified a human molar in ST 12 (see attached map). The molar was found within what appears to be an intact prehistoric horizon. No other human remains have been found. It is anticipated that a Phase 2 assessment will be conducted.
