TITLE: Motion Approving an Increase to the Civil Engineering Services Continuing

Agreements – AECOM Inc.; Black & Veatch Corporation; Calvin, Giordano & Associates, Inc.; Chen Moore and Associates, Inc.; Craven, Thompson & Associates, Inc.; Hazen and Sawyer, P.C.; and Kimley-Horn and Associates, Inc. – \$3,920,000 - (Commission Districts 1, 2, 3, and 4)

Associates, IIIc. – \$5,920,000 - (Collilliasion Districts 1, 2, 3, and 4)

Recommendation

Staff recommends the City Commission approve an increase to the Civil Engineering Services Continuing Agreements with AECOM Inc.; Black & Veatch Corporation; Calvin, Giordano & Associates, Inc.; Chen Moore and Associates, Inc.; Craven, Thompson & Associates, Inc.; Hazen and Sawyer, P.C.; and Kimley-Horn and Associates, Inc. in the amount \$3,920,000 for an estimated initial two-year term aggregate agreement total of \$6,920,000 (originally \$3,000,000). Additionally, for the two (2) one-year renewal options, staff recommends an increase of \$1,960,000 for an estimated annual renewal aggregate amount of \$3,460,000 (originally \$1,500,000), for a new potential total contract collective amount of \$13,840,000, to continue issuing task orders for the engineering and design of Community Investment Plan (CIP) projects.

Background

On February 25, 2022, the Procurement Services Division issued Request for Qualifications (RFQ) No. 12637-421 soliciting for qualified consulting firms to provide Civil Engineering Services for municipal projects on an as-needed basis. On February 21, 2023, the City Commission approved CAM #23-0069 awarding Civil Engineering Services Continuing Agreements to AECOM Technical Services; Black and Veach Corporation; Calvin Giordano and Associates, Inc.; Chen Moore and Associates, Inc.; Craven Thompson and Associates; Hazen and Sawyer, P.C.; and Kimley-Horn and Associates, Inc. These Agreements were awarded for an initial two (2) year term aggregate amount of \$3,000,000, to be distributed evenly amongst the consultants following the normal task order approval process. The City Manager was also authorized to approve two (2), one (1) year renewal options in the estimated annual renewal aggregate amount of \$1,500,000, for a potential total contract collective amount of \$6,000,000, contingent upon appropriation of funds. Even though it was intended to distribute the dollar amount evenly amongst the consultants, the task orders are now being issued by matching the

05/07/2024 CAM #24-0412 consultant's experience with project need, workload, qualifications, and any other factor deemed to be in the City's best interest.

Due to current workloads, the initial aggregate amount of \$3,000,000 has been exhausted prior to the completion of the initial two (2) year term. The cost capacity (CAP) increases, of \$3,920,000 to the initial term and \$1,960,000 to each of the renewal terms, are required to continue issuing task orders for the engineering and design of Community Investment Plan (CIP) projects.

Resource Impact

There will be a fiscal impact to the City in the amount of \$3,920,000 for this CAP increase. Funds for this Agreement, in the amount of \$3,920,000, are available in the FY2024 Community Investment Plan in the accounts listed below.
