

ORDINANCE NO. C-15-15

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SCHEDULE I OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY MODIFYING THE CLASS TITLE OF ONE CLASS, MODIFYING THE PAY RANGE OF SEVERAL CLASSES, AND MODIFYING THE MANAGEMENT CATEGORY OF SEVERAL CLASSES, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, it is recommended that Schedule I of the Pay Plan of the City of Fort Lauderdale, Florida, be amended by modifying the class title of one class, modifying the pay range of several classes, and modifying the management category of several classes,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Schedule I of the Pay Plan of the City of Fort Lauderdale, Florida, is amended by modifying the following classes as follows:


SECTION 3. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.
