

## FIRST EXTENSION TO AGREEMENT

CITY OF FORT LAUDERDALE, a municipal Corporation of the State of Florida, (hereinafter referred to as "CITY")

and

T.Y. Lin International, a California corporation authorized to do business in the state of Florida (hereinafter referred to as 'CONSULTANT')

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of August 23, 2011, authorized the proper officials by motion to execute an Agreement between CONSULTANT and CITY authorizing the performance of services in connection with Agreement, 616-10631 for Professional Traffic and Transportation Engineering Consultant Services (the "Agreement"); and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of August 21, 2012, authorized the proper officials by motion to execute a First Amendment to Agreement between CONSULTANT and CITY; and

WHEREAS, Section 6.1 of the Agreement authorizes renewal for two (2) successive one (1) year terms upon mutual consent of the parties; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted professional consultant services to CITY for an additional one year (1) period until August 22, 2014, utilizing the contract prices of the original Agreement; and

WHEREAS, at its meeting of \_\_\_\_\_, 2013, the City Commission, by motion, authorized the proper City Officials to execute this First Extension to Agreement;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

**Section 1.** The foregoing recitals are true and correct and are made a part of this First Extension to Agreement.

**Section 2.** That the Agreement between CITY and CONSULTANT dated August 23, 2011 is hereby extended for an additional one year (1) period, said term expiring on August 22, 2014.
