

RESOLUTION NO. 23-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, WAIVING THE COMPETITIVE SOLICITATION AND SELECTION PROCESSES CONTAINED IN THE CITY OF FORT LAUDERDALE PROCUREMENT ORDINANCE FOR APPROVING A LICENSE AGREEMENT WITH SLINKYDOG, LLC, FOR A PILOT PROGRAM UTILIZING THE LAS OLAS GARAGE ROOFTOP AMENITY DECK, FOR A PUTT PUTT MINIATURE GOLF COURSE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Slinkydog, LLC previously operated a Pixar Putt Putt miniature golf course as a special event in the Las Olas Oceanside Park, in the City of Fort Lauderdale, Florida, ("City) that was well received by the City's community; and

WHEREAS, the City owns and operates a public parking garage located at 200 East Las Olas Circle, that includes a rooftop amenity deck, which consists of open-air space of approximately 9,000 square feet that overlooks the Intracoastal Waterway in the City; and

WHEREAS, City staff wishes to explore using the rooftop amenity deck as a putt putt miniature golf course as part of a temporary pilot program; and

WHEREAS, City staff met with members of the Central Beach Alliance on May 12, 2023, and received supportive feedback for the putt putt miniature golf operation; and

WHEREAS, Slinkydog, LLC and the City will enter into a license agreement wherein Slinkydog, LLC will pay the City a licensee fee for use of the rooftop amenity deck to operate and manage a miniature golf course for public recreational activities; and

WHEREAS, pursuant to Section 2-176(e)(17) of the Code of Ordinances of the City of Fort Lauderdale, Florida, the competitive solicitation and selection processes shall not apply to "[p]urchases of goods or services for which the provisions of this article are waived by the city commission by resolution."; and

WHEREAS, if the temporary pilot program is successful, City staff will explore opportunities for a future longer-term use through a formal competitive solicitation process.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the competitive solicitation and selection processes, contained in the City of Fort Lauderdale Procurement Ordinance, are waived for approving a license agreement with Slinkydog, LLC, for a pilot program utilizing the Las Olas Parking Garage rooftop amenity deck for a putt putt miniature golf course.

SECTION 2. That this Resolution shall be in full force and effect upon adoption.
