A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DESIGNATING THE COMMONLY PROPERTY KNOWN AS "CASTRO CONVERTIBLES," LOCATED AT 2860 N. **FEDERAL** HIGHWAY, FORT LAUDERDALE, FLORIDA, AS A HISTORIC LANDMARK IN ACCORDANCE WITH SECTION 47-24.11.C.7. OF THE CITY OF FORT LAUDERDALE. FLORIDA. UNIFIED LAND DEVELOPMENT REGULATIONS, PROVIDING FOR CONFLICTS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 47-24.11.C.7. of the Unified Land Development Regulations of the City of Fort Lauderdale ("ULDR") includes the criteria for the historic designation of a property as a historic landmark; and

WHEREAS, at a public hearing on February 18, 2025, the City Commission of the City of Fort Lauderdale ("City Commission"), considered an application for the historic designation of a structure and site located at 2860 N. Federal Highway, Fort Lauderdale, Florida, commonly known as "Castro Convertibles" ("the Property"), as a historic landmark; and

WHEREAS, the City Commission found, upon reviewing the record and evidence presented at the public hearing, that the Property does meet the criteria for designation as a historic landmark under Section 47-24.11.C.7 of the Unified Land Development Regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the above recitals are true and correct and incorporated into this Resolution by reference.

<u>SECTION 2</u>. The City Commission hereby approves the application for the historic designation of the Property as a historic landmark.

<u>SECTION 3</u>. The historic designation landmark status shall apply to the Property located at 2860 N. Federal Highway, Fort Lauderdale, Florida, and legally described in Exhibit "A" attached hereto and incorporated herein.

<u>SECTION 4</u>. The Property designation of the historic landmark and landmark site shall take effect immediately upon adoption of this Resolution.

SECTION 5. The City Clerk is hereby directed to provide a certified copy of this Resolution to the applicant and the property owner within thirty (30) days of the adoption of this Resolution, and to record a copy of this Resolution in the Public Records of Broward County, Florida.
