The Consultant provided a letter stating there is potential for the site to contain intact archaeological deposits. The property contains elements of previously recorded Florida Master Site File archaeological site 8BD2915 / Annie Tommie Camp (Seminole) and is in proximity (< 300 feet) to Florida Master Site File archaeological site 8BD2906 / Seminole Burial Ground (FMSF 2025). The property is likely to contain site 8BD2915 / Annie Tommie Camp and possibly portions of site 8BD2906 / Seminole Burial Ground. Future development of the property is likely to have an adverse effect on these resources and prior to any ground disturbances an intensive archaeological survey (Phase 1b-Phase II) should be completed.
