

RESOLUTION NO. 24-116

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A LOCALLY FUNDED AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION UNDER PROJECT FM NUMBERS 450866-1-32-01 WEST LAKE DRIVE AT LUCILLE RIVER (BRIDGE #865773), 450867-1-32-01 WEST LAKE DRIVE AT MERCEDES RIVER (BRIDGE #865774), 4580868-1-32-01 WEST LAKE DRIVE AT ESTELLE RIVER (BRIDGE #865771), AND 450870-1-32-01 SE 7<sup>TH</sup> STREET AT RIO CORDOVA (BRIDGE #865760) IN THE AMOUNT OF \$3,089,491 WITH A TWENTY-FIVE PERCENT (25%) CITY OF FORT LAUDERDALE MATCH IN THE AMOUNT OF \$1,235,796 FOR THE DESIGN PHASE OF THE BRIDGE REPLACEMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 11, 2022, Florida Department of Transportation ("FDOT") allocated funding for the replacement of four (4) bridges: West Lake Drive at Lucille River (Bridge #865773), West Lake Drive at Mercedes River (Bridge #865774), West Lake Drive at Estelle River (Bridge #865771), and SE 7<sup>th</sup> Street at Rio Cordova (Bridge #865760); all are owned by the City of Fort Lauderdale ("City"); and

WHEREAS, the City and FDOT wish to execute a Locally Funded Agreement in the amount of \$3,089,491 to provide for the design phase of the bridge replacements; and

WHEREAS, the total estimate design cost for the four (4) bridges is \$4,119,321; and

WHEREAS, the design specifications will conform to the FDOT Design Manual for bridge structural components and the Florida Greenbook for non-structural components; and

WHEREAS, the design documents will include plans and specifications packages in accordance with FDOT Standard Specifications for structural components and local agency specifications for non-structural components; and

WHEREAS, the City is required to pay FDOT within 30 days of execution of the Locally Funded Agreement in the amount of \$1,235,796 for its required twenty-five (25%) contribution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to execute a Locally Funded Agreement in the amount of \$3,089,491 with the Florida Department of Transportation for design phase of four (4) bridges: West Lake Drive at Lucille River (Bridge #865773), West Lake Drive at Mercedes River (Bridge #865774), West Lake Drive at Estelle River (Bridge #865771), and SE 7<sup>th</sup> Street at Rio Cordova (Bridge #865760).


SECTION 2. The office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.
