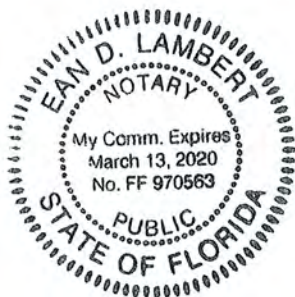

HISTORIC CRITERIA

First Lutheran Church

A) Its Value as a Significant Reminder of the Cultural or Archeological Heritage of the City, State or Nation.

This building was originally St Anthony's Church, the first Roman Catholic Church in Broward County. It was built on what is now Las Olas Boulevard, in 1921. When St. Anthony's congregation grew too big for this building, they sold it to the First Lutheran Church, which was meeting in the Woman's Club, for one dollar. In the mid-to-late 1940's it was moved brick by brick down NE Third Avenue and reconstructed by the same contractor, John Olsson, who was a founding member of First Lutheran Church. The bricks were carefully numbered and reconstructed like a puzzle.

B) Its Location as a Site of a Significant Local, State or National Event.

In an amazing display of generosity, this local Roman Catholic congregation sold its church building for the sum of one dollar (\$1) to the Lutherans. This is the same denomination founded by Martin Luther that started the Reformation, the Revolution of Protestants that tore away from the Roman Catholic Church. Early Fort Lauderdale was very prejudiced against Catholics, in fact a school teacher in 1915 named Julia Murphy was fired when it was found out that she was Catholic. In spite of such prejudice at the time, this local Catholic Church displayed such love and kindness to share its building with the local Lutheran congregation as they started up. The year 2017 marks the 500 year anniversary of Martin Luther starting the Reformation by nailing his 95 Theses to the doors of the church in Wittenberg. Our journey to save this local landmark will lend itself to the global story and projects of Luther500 and Wittenberg500, and bring international attention to a unique and treasured Fort Lauderdale story.

E) Its Value as a building recognized for the quality of its Architecture, and sufficient elements showing its architectural significance.

This is a rare Romanesque Style building, completely unique for Fort Lauderdale and Florida in general. The architect is a "Builder-Priest" named Father G.J. Plunkett, also known as "the first Pastor of Fort Lauderdale". Father Plunkett was sent from Tennessee in 1922 to design and oversee the building of this church. Plunkett is responsible for designing and overseeing the building of many churches in Florida, during the boom time of expansion and pioneering.

F) It's distinguishing characteristics of an architectural style valuable for the study of a period, method of construction, or use of indigenous materials

The grey stones were quarried in Northern Florida. The faceted stained glass windows were made by the world famous Conrad Pickel studios of Vero Beach, who also crafted other stained glass windows at the same time period, in Broward County and down the coastline of Florida. These windows share a similar style to the other regional churches.

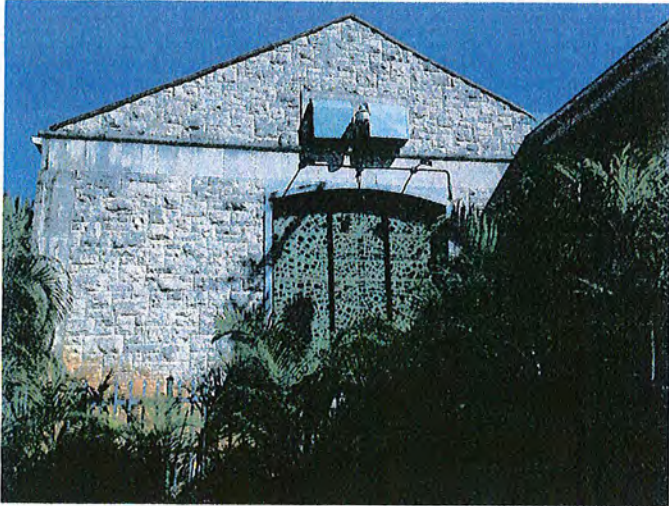

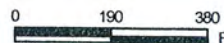
