The meeting was called to order by Chair Blattner at 6:02 p.m. The roll was called, and it was determined a quorum was present.

Communication to the City Commission

The Sustainability Advisory Board (SAB) provides the following Communication to the City Commission:

The SAB received a presentation on October 24, 2022, from Stefan Perritano, Sustainability Coordinator in the Public Works Department, on the proposed modifications to the Unified Land Development Regulation (ULDR) Section 47-19.3 Boat slips, docks, boat davits, hoists, and similar mooring structures and the creation of Section 47-19.13 - Resiliency Standards for Tidal Flood Protection.

The proposed modifications strengthen coastal resilience, mitigate the effects of tidal flooding and sea level rise, and promote the health of coastal ecosystems. In addition, the revised ordinance would bring the City into compliance with existing Broward County regulations and is consistent with the City's Comprehensive Plan and Press Play Fort Lauderdale. The Sustainability Advisory Board urges the City Commission to adopt the proposed modifications supporting regionally-consistent top elevations standards for seawalls, banks and berms, and other tidal barriers.

These ordinance modifications support the following strategic connections:

Comprehensive Plan

- POLICY CC 2.2.3: Ensure that adaptation to climate change impacts, especially sea level rise and flooding, is incorporated into the planning, siting, construction, replacement, and maintenance of public infrastructure in a manner that is cost-effective, captures cobenefits of the investment and that maximizes the use of the infrastructure throughout its expected service life.
 - POLICY CC 2.2.3a: To ensure coordination, consistency and maximum effectiveness of coastal improvements necessary to mitigate high tide flooding associated with realized and additional sea level rise through the year 2070, the City will adopt and update, as necessary, regionally consistent top elevations standards for seawalls, banks and berms, and other appurtenant coastal infrastructure (e.g., boat ramps) consistent with the findings and recommendations of the United States Army Corps of Engineers/Broward County Flood Risk Management Study for Tidally Influenced Coastal Areas. These standards shall be consistent with Chapter 39, Article XXV Resiliency Standards for Flood Protection of the Broward County Code of Ordinances.
- POLICY CM 4.2.3: Continue to foster effective collaborations, partnerships (including P3), and coordination with national, state, regional, and local partners to identify risks, vulnerabilities, and opportunities associated with coastal hazards and the impacts from sea level rise.

LEED for Cities Update

Mr. Perritano provided an update on LEED for Cities. He stated that a staff meeting was held recently to review progress and address information needed. He stated that the City intended to submit its draft application in December and, hopefully, achieve LEED Gold certification by April 2023, which would match the highest rating of any city in Florida.

Resolution in Support of Broward Solar Co-Op

Mr. Hadwen explained the City Commission had officially accepted a resolution to support the Broward Solar Co-Op, making the City an official partner. He stated this allowed Strategic Communications to conduct outreach related to the program.

Urban Farming

Leann Barber of Made in Broward shared a *PowerPoint* presentation titled "Food Forests in Fort Lauderdale." She discussed the three (3) urban food forests in central Broward County and the interest developing in getting involved with the concept. She shared definitions of the gardening technique and actions the City could take to garner additional participation and interest. Joan Starr, City of Fort Lauderdale Parks & Recreation staff, provided additional detail regarding the farm in Snyder Park.

Tidal Barrier Ordinance

Comments

Ms. Charles asked what was happening with pickleball courts in Snyder Park. She stated she did not want to lose a lot of green space. Mr. Hadwen stated that he would investigate and report back.

Ms. Charles inquired as to whether there were any cities with ordinance related to Florida Power & Light (FPL) cutting trees. She asserted they do a poor job. Mr. Hadwen stated he would ask the City's Urban Forester and noted there may be State regulation supersedes what the City can do, and his understanding is that FPL has a right to trim.

Ms. Mazza asked if anyone had details on Ygrene stopping PACE funding. Mr. Hadwen stated their funding sources were no longer available due to higher interest rates. He stated he had reached out to other PACE programs and the others are still actively providing PACE funds.

Items for Next Meeting

Mr. Hadwen discussed electrical vehicle infrastructure, and stated staff was looking at an electric vehicle charging ordinance which would require a certain number of chargers in a parking area. He stated Coral Gables had recently passed what may be the most aggressive ordinance of this type in the country. Discussion ensued.

Mr. Perritano stated a presentation on LEED for Cities could be made in December.

Ms. Mazza suggested a presentation regarding the Infrastructure Bill. Mr. Hadwen stated he had given a presentation on the Inflation Reduction Act and the Infrastructure Bill, but the Federal government had not yet laid out criteria and administration.

Ms. Thordin asked for confirmation that the Board had determined there was no action they could take at this time regarding food forests. Mr. Hadwen stated they had determined the program could use Green Your Routine funding and could be further discussed at a future meeting.
