\$350,000 from the Florida Department of Education - **(Commission  
Districts 1, 2, 3 and 4)**

**Recommendation**

Staff recommends the City Commission adopt a resolution approving the acceptance of grant funds in the amount of \$350,000 from the Florida Department of Education and authorizing the City Manager to execute any documents necessary to accept the grant funds and implement the Education Enrichment Program.

**Background**

During the 2025 Legislative Session, the City of Fort Lauderdale requested a state appropriation for the Education Enrichment Program (the "Program") in the amount of \$350,000. This request was included in the FY2025/26 State Budget.

Through the Program, the City has continued to expand academic enrichment offerings through summer and after-school programs utilizing CARES Act and Enrichment Grant funds in which more than 2,000 children and youth have benefited and demonstrated increases in academic and workforce development. This funding builds on the success of the City's summer academic program and expands services to include after-school enrichment, workforce exploration and citizenship development. Offerings will include Promoting Lifetime Activities for Youth (PLAY) After-School Program, Teen Recreational Intramural Passport (TRIP) Program, community Summer Camp academic enrichment, and summer job readiness and internships.

With the City's continued partnerships with the YMCA (CAM #26-0158) and Experience Aviation (CAM #26-0159), the Program will support comprehensive workforce development, combining structured training with paid on-the-job learning opportunities.

**Resource Impact**

There is a positive fiscal impact to the City in the amount of \$350,000 which will allow for project implementation in FY 2026 and expanded services to include after-school enrichment, workforce exploration and citizenship development. This item is contingent

upon the approval of the Consolidated Budget Amendment (CAM #26-0059).
