Lot Improvements - Sagaris Corp. - \$559,712 - (Commission Districts 2

and 4)

#### Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Parking Lot Improvements at Fort Lauderdale Beach Park Parking Lot with Sagaris Corp. in the amount of \$559,712.

#### **Background**

The Fort Lauderdale Beach Park Parking Lot is located at 1100 Seabreeze Boulevard, Fort Lauderdale, FL 33316. In June 2022, Transportation and Mobility completed a milling and resurfacing improvement project within the lot. The Beach Business Improvement District (BBID) requested improvements to the lot to accommodate the hosting of beach events in the area. The City also requested additional modifications within the parking lot for easier maneuverability during the special events on the beach. The BBID has been involved in the planning and design phase of the project and has contributed \$750,000 in funding to support the project. The work to be accomplished under this contract includes, but is not limited to, site preparation, earthwork, asphalt pavement installation, pavement marking installation, signage installation, concrete curb, gutter, and sidewalk construction, landscape restoration, and irrigation to help support special events held at this location.

On June 9, 2023, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 130-10.

The City received the following two (2) bids in response to the solicitation, which was opened on August 9, 2023:

- Florida Blacktop, Inc. \$1,121,403.30
- Sagaris Corp \$559,712.00

We also received a 'no bid' from Tectonic Group International, LLC

None of the bidders have identified as a Disadvantaged Business Enterprise.

### **Resource Impact**

There is a fiscal impact in the amount of \$559,712. This project is being funded from the Fort Lauderdale Beach Park Parking Lot Improvements fund, as well as Beach Business Improvements District (BBID).
