**SECOND AMENDMENT AND EXTENSION OF
AGREEMENT BETWEEN THE CITY OF FORT
LAUDERDALE AND KEITH AND SCHNARS, P.A.**

THIS IS A SECOND AMENDMENT AND EXTENSION OF AGREEMENT, made and entered into this 2nd day of December, 2014 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and KEITH AND SCHNARS, P.A., a Florida Corporation ("CONSULTANT").

WHEREAS, the CITY and Keith and Schnars, P.A., a Florida corporation, entered into an agreement for civil engineering utility design, construction management, appraisal and community outreach consultant services for undergrounding above ground utility lines, RFQ 686-9879, dated December 16, 2008, which agreement was extended and amended via First Extension and Amendment to Agreement dated November 6, 2012, (the "Agreement"); and

WHEREAS, the Agreement provides for three two-year renewal options; and

WHEREAS, due to no fault of the CITY nor the CONSULTANT, the project will continue past the original contract expiration date; and

WHEREAS, the City Manager has determined that it is in the CITY's best interest to complete the project with the current CONSULTANT; and

WHEREAS, CITY and CONSULTANT desires to amend the term to allow the contract to continue until cancellation by the CITY; and

WHEREAS, accordingly, the CITY has deemed this to be a proprietary contract; and


WHEREAS, at its meeting of December 2, 2014, the City Commission of the City of Fort Lauderdale authorized this amendment and extension to agreement, and


NOW, THEREFORE, the CITY and the CONSULTANT agree as follows:

1. The agreement is now a proprietary agreement that shall continue until cancellation by the City.


