TITLE: **WALK-ON ITEM** -Motion to approve Work Order No. 4 with Weekley Asphalt Paving Inc., under the Annual Asphaltic Concrete Pavement Contract - \$260,000

Recommendation

It is recommended that the City Commission approve Work Order No. 4 with Weekley Asphalt Paving Inc., under the Annual Asphaltic Concrete Pavement Contract for the paving of streets in the Dorsey Riverbend Neighborhood (District 3).

Background

Under the City's agreement with Housing and Urban Development (HUD), the City would utilize Community Development Block Grant (CDBG) funds, to resurface streets in the Dorsey Riverbend Neighborhood.

The City would utilize \$260,000 in CDBG funds, to fund the work in the eligible areas. The work will be performed through the Annual Asphaltic Concrete Pavement unit cost contract. Weekley Asphalt Paving has agreed to accept the contract amendment, which makes the vendor eligible to perform work on projects funded by CDBG funding.

This CAM is being presented as a walk on item to meet the spending requirements and deadlines associated with CDBG funds as the CDBG funds do need to be spent before July 25th. To accomplish the required spending of funds, work must also be completed in time to provide payment by July 25th.

The streets that would be resurfaced under this project include the following:

1. NW 20 Avenue South from NW 6 Street to NW 3 Court
2. NW 19 Avenue South from NW 6 Street to NW 3 Court
3. NW 18 Avenue South from NW 7 Street to NW 3 Court
4. NW 17 Avenue South from NW 5 Street to NW 4 Street
5. NW 3 Court East from NW 20 Avenue to Cul-de-Sac
6. NW 17 Avenue North from NW 3 Court to the end

7. NW 4 Street East from NW 18 Avenue to NW 16 Avenue
8. NW 5 Street East from NW 20 Avenue to NW 17 Avenue
9. NW 15 Avenue North from Broward Boulevard to NW 3 Street
10. NW 14 Avenue North from NW 15 Avenue to NW 3 Street
11. NW 3 Street east from NW 15 Avenue to NW 12 Avenue
12. NW 2 Street East from NW 15 Avenue to NW 12 Avenue
13. NW 1 Street from NW 15 Avenue to NW 12 Avenue

Resource Impact

The estimated fiscal impact to the City is in the amount of \$260,000 in CDBG funds. This includes \$235,000 for the Work Order and \$25,000 for engineering fees which will cover asphalt testing and in house construction management.
