Recommendation

Staff recommends the City Commission approve a Consent to Assignment and Assumption of Agreement, in substantially the form attached, for pumping services from All Liquid Environmental Service LLC d/b/a Johnson Environmental Services (Johnson) to Blerman LLC d/b/a Raider Rooter (Raider Rooter).

Background

On September 6, 2022, the City awarded Contract No. 12576-323, for an initial two-year term with two one-year renewals to Johnson for pumping services (CAM #22-0575). The agreement is in the first renewal period until September 5, 2025.

On October 31, 2024, Johnson (Seller) was purchased by Raider Rooter (Buyer). As part of the transaction, Seller assigned its contracts to Buyer and Buyer assumed certain liabilities as outlined in the Asset Purchase Agreement (Exhibit 2).

The Agreement between the City and Johnson, Section N., <u>Assignment and Performance</u>, states in part: "Neither this Agreement nor any right or interest herein shall be assigned, transferred, or encumbered without the prior written consent of the other party" (Exhibit 1).

Staff is hereby requesting approval by the City Commission to approve the assignment and assumption from All Liquid Environmental Service LLC d/b/a Johnson Environmental Services to Blerman LLC d/b/a Raider Rooter.
