(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission adopt a resolution approving and ratifying a first amendment to Collective Bargaining Agreement (CBA) between the City of Fort Lauderdale and Teamsters Local Union 769, Affiliated with International Brotherhood of Teamsters.

Background

The City Commission ratified a CBA with the Teamsters Local 769 on October 18, 2022 for the period October 3, 2022 through September 30, 2025. In a previous agreement, the DROP program was eliminated for Teamsters members after January 14, 2004. Recently, the union requested the City consider reinstating the DROP for its members and an impact bargaining session was held on January 4, 2024. At time of publication of agenda, the first amendment to the CBA (Exhibit 1) is expected to be ratified by Teamsters Members on January 19, 2024.

Resource Impact

There is no fiscal impact associated with this change (Exhibit 2 - Actuarial Impact Statement).

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AND RATIFYING A FIRST AMENDMENT TO COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF FORT LAUDERDALE AND TEAMSTERS LOCAL UNION NO. 769, AFFILIATED WITH INTERNATIONAL BROTHERHOOD OF TEAMSTERS, AND AUTHORIZING EXECUTION OF THE FIRST AMENDMENT TO COLLECTIVE BARGAINING AGREEMENT.

WHEREAS, the City of Fort Lauderdale and Teamsters Local Union No. 769, Affiliated with International Brotherhood of Teamsters, have entered into a collective bargaining agreement for the period of October 1, 2022, through September 30, 2025;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That a First Amendment to Collective Bargaining Agreement between the City of Fort Lauderdale and Teamsters Local Union No. 769, Affiliated with International Brotherhood of Teamsters, ("First Amendment"), in substantially the form attached to City Commission Agenda Memo No. 24-0067, is hereby approved and ratified, and the City Commission authorizes execution of the First Amendment.

FIRST AMENDMENT TO COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF FORT LAUDERDALE AND TEAMSTERS LOCAL UNION 769, AFFILIATED WITH INTERNATIONAL BROTHERHOOD OF TEAMSTERS

THIS FIRST AMENDMENT TO COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF FORT LAUDERDALE AND TEAMSTERS LOCAL UNION 769, AFFILIATED WITH INTERNATIONAL BROTHERHOOD OF TEAMSTERS, ("First Amendment"), dated this 23rd day of January, 2024, is entered into by and between the City of Fort Lauderdale, a Florida municipality, and Teamsters Local Union 769, affiliated with International Brotherhood of Teamsters, a Florida collective bargaining representative, ("Teamsters").

WHEREAS, the City of Fort Lauderdale and the Teamsters entered into a collective bargaining agreement for the period October 1, 2022, through September 30, 2025, ("Collective Bargaining Agreement"); and

WHEREAS, the City's and the Teamsters' bargaining agents have reached tentative agreement to amend the Collective Bargaining Agreement by deleting Section 10 of Article 50 in order to reinstate the ability of bargaining unit members to participate in the City of Fort Lauderdale General Employees' Retirement Plan's Deferred Retirement Option Program effective upon adoption of a corresponding ordinance; and

WHEREAS, the Teamsters have ratified this First Amendment,

NOW, THEREFORE, the City and the Teamsters agree as follows:

Effective upon the City's adoption of a corresponding ordinance, Section 10 of Article 50 of the Collective Bargaining Agreement, shown as stricken, to wit:

Section 10. Effective January 14, 2004, the Deferred Retirement Option Plan (DROP) will no longer be available to Group I and Group II members. Employees already in DROP will be permitted to complete any remaining DROP time.
