**TITLE:** Public Hearing - Resolution Denying a Waiver of Limitations at 801 SW 6<sup>th</sup> Street, for the installation of three (3) triple cluster mooring piles, each mooring pile being 12" in diameter, extending a maximum of 60'+/- from the property line into the New River – **(Commission District 4)**

**Recommendation**

Staff recommends the City Commission adopt a Resolution denying a Waiver of Limitations for the installation of three (3) triple cluster mooring piles, each mooring piles being 12" in diameter, extending a maximum of 60'+/- from the property line into the New River.

**Background**

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow piles to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 D of the Unified Land Development Regulations (ULDR) for the installation of three (3) triple cluster mooring piles extending a maximum of 60'+/- from the property line into the New River.

The applicant's Summary Description specifies that the proposed structures are necessary for safely mooring resident's vessels due to significant boat wakes along the New River, as well as during extreme weather events.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended denial of the application 7:0 (see Exhibit 3) at the November 3, 2022, MAB meeting.

**Resource Impact**

There is a positive fiscal impact in the amount of \$1,500.00. Revenue related to the application fee is included in the FY2023 Operating Budget in the account listed below.
