

RESOLUTION NO. 17-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE FINAL OPERATING BUDGET AND COMMUNITY INVESTMENT PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, AND ENDING SEPTEMBER 30, 2017, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #17-0751, ABANDONING THE BAHIA MAR DREDGING PROJECT, THE BARRIER ISLAND PARKING GARAGE PROJECT, THE SEBASTIAN STREET/ALHAMBRA STREET PARKING GARAGE PROJECT, THE SUSTAINABLE PARKING LOT IMPROVEMENTS PROJECT, AND THE MOBILE ENFORCEMENT FOR CITYWIDE PARKING ENHANCEMENT PROJECT, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 16-157, adopted on September 12, 2016, the City Commission of the City of Fort Lauderdale, Florida, adopted the Final Operating Budget and Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Final Operating Budget and Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, are hereby amended by appropriating funds as set forth in Commission Agenda Memo #17-0751, a copy of which is attached hereto and incorporated herein.

SECTION 2. That the Bahia Mar Dredging Project, the Barrier Island Parking Garage Project, the Sebastian Street/Alhambra Street Parking Garage Project, the Sustainable Parking Lot Improvements Project, and the Mobile Enforcement for Citywide Parking Enhancement Project, appropriated in the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, are hereby abandoned.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution Approving the Consolidated Budget Amendment to Fiscal Year
2017 – Appropriation

Recommendation

It is recommended that the City Commission adopt a resolution amending the Fiscal Year 2017 Budget and Community Investment Plan (CIP) and abandoning the Bahia Mar Dredging, Barrier Island Parking Garage, Sebastian Street/ Alhambra Street Parking Garage, Sustainable Parking Lot Improvements, and Mobile Enforcement for Citywide Parking Enhancement projects.

Background

Examples of recommended actions within the budget amendment include:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff is recommending that the City Commission amend the FY 2017 Operating Budget and Community Investment Plan by approving the following transfers and appropriations:

Transportation and Mobility

A. Transfer of Operating Budget to Community Investment Plan - General Fund, General Capital Projects Fund – Shady Banks Entryway Project – \$100,000

The purpose of this request is to transfer General Fund operating funds to create a Community Investment Plan project to improve Shady Banks Neighborhood entryways. These improvements were identified by the Shady Banks Neighborhood through their Neighborhood Mobility Master Plan. The neighborhood's priority was to address the speed of vehicles entering their neighborhood and the volume of cut through traffic.

Staff recommends that the City Commission amend the FY 2017 Budget and Community Investment Plan in the amount of \$100,000 for the Shady Banks Entryway project.

B. Transfer Between Community Investment Plan and Operating Budget and Appropriation of Fund Balance – Stormwater Fund, Park Impact Fee Fund – Bayshore Drive Stormwater Improvements Project – \$44,382

The purpose of this request is to transfer funds from the Stormwater operating budget and to appropriate Park Impact Fees to the Bayshore Drive Stormwater Improvements project. With these funds, staff recommends the modification of the scope of the current Bayshore Drive Stormwater Improvements project to add the creation of a park.

Staff recommends that the City Commission amend the FY 2017 Budget and Community Investment Plan in the amount of \$44,382 for the Bayshore Drive Stormwater project.

C. Appropriation of Fund Balance – Airport Fund – Taxiway Intersection Improvements Project - \$480,008

The purpose of this request is to fund a new project for the demolition and re-construction of two areas within the airfield of the Fort Lauderdale Executive Airport (FXE) to improve safety at these locations. Currently these areas allow for direct access from the taxiway to the runway. The new alignments will reduce the number of taxiway intersection crossings for pilots thereby reducing the risk of accidental runway incursions and will also conform to the current Federal Aviation Administration design standards. Funding for this improvement is available in the Airport's fund balance.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$480,008 for the taxiway intersection improvements project.

D. Appropriation of Fund Balance and Un-anticipated Revenue and Transfer of funding from Community Investment Plan projects – Parking Fund, Parking Revenue Bond Construction Fund – Funding for Las Olas Corridor Improvement Projects - \$13,000,000

Abandoning of Barrier Island Parking Garage, Sebastian Street/ Alhambra Street Parking Garage, Sustainable Parking Lot Improvements, and Mobile Enforcement for Citywide Parking Enhancement projects

The current year's Community Investment Plan included estimated revenue of \$13 million from the issuance of parking revenue bonds to support the Las Olas Marina Garage construction project. Since the bonds were not issued during FY 2017, the appropriation of Parking Fund Balance and the temporary abandonment of projects funded in the Parking Fund is necessary to replace the proposed bond funds until such time financing can be secured.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$13,000,000 to fund the Las Olas Corridor Improvement Project.

Parks and Recreation

E. Transfer between Community Investment Plan projects – General Capital Fund - Carter Park Pool Fence – \$160,085

Facility Maintenance staff has determined that the fence at Carter Park Aquatic Center can no longer be repaired and needs to be replaced. Funding is available in the facilities assessment project to transfer for this priority project.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$160,085 for the Carter Park Pool Fence.

F. Appropriation of Grant Funds - Grant Fund – Afterschool Snack Program – \$55,728

The City of Fort Lauderdale anticipates a grant in the amount of \$55,728 from the Florida Department of Health to provide free nutritional snacks at the various City parks. The grant funds will reimburse the City for lunches and snacks, operational expenses, and program monitoring. No City match is required for this grant.

Staff recommends that the City Commission amend the budget in the amount of \$55,728 for the afterschool snack program grant.

G. De-appropriation of Grant Funds and Transfer between Capital Projects - Grant Fund, Community Redevelopment Agency Fund – De-appropriation of Bahia Mar Marina Dredging Grant – (\$206,543)

Abandonment of Bahia Mar Dredging Project

The Florida Inland Navigation District (FIND) has nearly completed dredging the Intracoastal Waterway (ICW) from Port Everglades to approximately 5,000 feet north of the Las Olas Blvd. Bridge to 17 feet at mean low water.

In 2015, the City applied for and was awarded funding assistance from FIND to complete the Design and Permitting Phase of dredging access to the Bahia Mar Yachting Center from the deepened ICW.

Bahia Mar Yachting Center has completed the design and permitting phase on its own and the City is now working with Bahia Mar complete the construction phase of the work. Since design and permitting is complete, FIND funding assistance is not needed and the grant can be closed.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of (\$206,543) to de-appropriate the FIND grant for Bahia Mar Dredging. There is an associated CAM# 17-0985.

H. Transfer Between Capital Projects – Water and Sewer General Capital Projects Fund, General Capital Projects Fund – Plant A Roof Replacement – \$45,975

Staff has surveyed the condition of the roof at the Trash Transfer Station-Plant A, along with the roofing contractor, and it has been determined that the roof is beyond repair and must be replaced. Funding for the project will come from the Facilities Assessment – Roofing Priorities project that is used until specifically scoped roofing project costs can be clearly estimated and the Security Gate Replacement project at the Public Works Administration compound, which is expected to be completed under budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$45,975 for a priority roof replacement project.

I. Appropriation of Trust Funds – Commemorative Tree Canopy Trust Fund – Enhanced Tree Canopy Eligible Expenses – \$199,329

Funding for the planting of trees and ancillary expenses is funded through collected tree fines, which are deposited and held in a Tree Canopy Trust Fund. The City utilizes these funds to purchase trees and palms, irrigation supplies, mulch, tree grates, and to relocate trees in the City. In addition, the funds are used to support the City's Tree Give-A-Way Program, which is one of the primary initiatives used to meet the City's Strategic Plan Goal 3 – Objective 4, "Cultivate our urban forest". Quarterly tree give-a-ways have become popular with our neighbors and they target specific areas of the low canopy. Approximately 500 trees are given away each quarter.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$199,329 to enhance tree canopy coverage.

Police

J. Transfer to Grant Match Account – Grant Fund, General Fund – Closing of FY 2016 Florida Inland Navigation District (FIND) Grant for Dive Team Search and Rescue - \$328

On December 6, 2016, the City Commission approved a grant award in the amount of \$21,000 from the Florida Inland Navigation District (FIND), as well as the use of \$21,000 from the City's General Funds to meet the grant program's required 50% cash match. This grant has been completed and resulted in a cost savings of \$328. This budget amendment will return the unused General Fund match to the General Fund's grant match account in order to close the grant.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$328 to facilitate closing of the FY 2016 dive team search and rescue grant.

Information Technology Services

K. Appropriation of Fund Balance – Central Service Fund – Payment Card Industry (PCI) Compliance – \$115,636

The City's Information Technology Services (ITS) department has taken the lead in ensuring Payment Card Industry (PCI) compliance throughout the City's various departments. During the FY 2017 budget process, these expenses were not anticipated. The purpose of this item is to reimburse the ITS operating budget for unanticipated PCI compliance expenses incurred during FY 2017.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$115,636 for PCI compliance expenses.

L. Transfer from Operating Funds to Community Investment Plan Projects – Central Service Fund – Data Center Consolidation – \$562,128

Information Technology Services (ITS) requests to move funds from its FY 2017 operating budget into associated Community Investment Plan Projects to implement related project scopes for data center consolidation concurrently for efficiency. The operating funds are in support of various objectives that play a role in the department's core goal of consolidating from four data centers to two.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$562,128 for data center consolidation

Community Redevelopment Agency (CRA)

**M. Transfer Between Incentives – Community Redevelopment Agency (CRA)
Business Incentives Fund – CRA Development Incentives – \$1,350,000**

The YMCA of South Florida is receiving \$10 million in funding assistance package from the Northwest-Progresso-Flagler Heights CRA to provide funding towards debt service for the construction and development of a \$15 million dollar state of the art community center, located within the CRA's Focus Area on historic Sistrunk Boulevard.

In addition to the YMCA \$1,250,000 funding for FY 2017, the Community Redevelopment Agency will also need to add \$100,000 for All Aboard Florida and Brightline Incentive projects.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$1,350,000 to transfer funds for development incentives. There is an associated CAM 17-0978.
