TITLE: Motion to Accept 2012 Edward Byrne Justice Assistance Countywide

Solicitation Grant Program Funds - \$15,000

#### **Recommendation**

It is recommended that the City Commission approve a motion authorizing the proper City officials to accept \$15,000 in additional funding from the 2012 Edward Byrne Justice Assistance Countywide Solicitation Grant Program.

#### **Background**

On December 4, 2012, the City Commission approved the acceptance of \$56,943 in grant funding under the 2012 Edward Byrne Justice Assistance Countywide Solicitation Grant Program. The grant funds support Operation Trend Buster's efforts to reduce the availability of marijuana being sold to students in proximity to Fort Lauderdale based schools and the sale of alcohol products to underage persons by local vendors. The additional funding will support training conference travel expenses for the project's lead investigator and continue to support the investigative and enforcement activities necessary to successfully implement this project.

Investigations & Enforcement Activities Overtime Expenses: \$14,216
Florida Alcohol and Drug Association Conference Travel Expenses: \$784

## Special Conditions

Modifications to this grant project must be completed via the Florida Department of Law Enforcement's on-line grant's management system. The additional funding must be spent by the project's current September 30, 2013 ending date.

### **Resource Impact**

There is an anticipated positive fiscal impact to the City in the amount of \$15,000. This item is contingent upon approval of the consolidated budget amendment CAM #13-0688.
