AN ORDINANCE AMENDING SECTION 47-1.6.B OF THE CITY OF FORT LAUDERDALE, FLORIDA UNIFIED LAND DEVELOPMENT REGULATIONS THROUGH THE REVISION OF THE OFFICIAL ZONING MAP OF CITY OF FORT "A" LAUDERDALE AND **SCHEDULE** REVISED COMPILATION ATTACHED THERETO AND BY REFERENCE MADE A PART THEREOF, SO AS TO RESIDENTIAL **MULTIFAMILY** REZONE FROM MID RISE/MEDIUM HIGH DENSITY DISTRICT ("RMM-25") TO NORTHWEST REGIONAL ACTIVITY CENTER-MIXED USE EAST DISTRICT ("NWRAC-MUe"), ALL OF LOTS THROUGH 19 INCLUSIVE AND LOTS 30 THROUGH 41 INCLUSIVE, BLOCK 261, "PROGRESSO" ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 2, PAGE 18. OF THE PUBLIC RECORDS OF DADE COUNTY. FLORIDA, LOCATED SOUTH OF NORTHWEST STREET, EAST OF NORTHWEST 3RD AVENUE. WEST OF NORTHWEST 2<sup>ND</sup> AVENUE AND NORTH OF NORTHWEST 8<sup>TH</sup> STREET, ALL SAID LANDS BEING IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, the applicants, 816 NW 3rd Ave LLC, 819-821 NW 2nd Ave LLC, Lot 19 NW 2 Ave LLC, Shalommax LLC, and WSC Coastline Properties LLC, applied for the rezoning of certain property as more particularly described in Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, on May 21, 2025, the Planning and Zoning Board (PZ Case No. UDP-Z24004) did recommend to the City Commission of the City of Fort Lauderdale ("City Commission") that certain lands herein described should be rezoned in the respects mentioned and that the Official Zoning Map and Schedule "A" attached thereto should be amended to include such lands; and

WHEREAS, the City Clerk notified the public of a public hearing to be held on Wednesday, September 3, 2025, at 6:00 P.M., and Tuesday, September 16, 2025, at 6:00 p.m., or as soon thereafter as possible, at the Broward Center for the Performing Arts, Mary N. Porter Riverview Ballroom, 201 Southwest 5<sup>th</sup> Avenue, Fort Lauderdale, Florida, for the purpose of hearing any public comment to such rezoning; and

WHEREAS, such public hearing was duly held at the time and place designated after notice of same was given by publication as required by law, and the City

Commission determined that the requested rezoning met the criteria for amending the zoning regulations;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The City Commission finds that the application for rezoning meets the criteria of Section 47-24.4 of the Unified Land Development Regulations ("ULDR") as enunciated and memorialized in the minutes of its meetings of September 3, 2025, and September 16, 2025, a portion of those findings expressly listed as follows:

### [SPACE RESERVED FOR FINDINGS OF FACT]

<u>SECTION 2</u>. That the City of Fort Lauderdale ULDR together with the Official Zoning Map of the City of Fort Lauderdale and revised Schedule "A", describing the lands lying within each zoning district, as approved on June 18, 1997, and described in Section 47-1.6 of the ULDR, be amended by rezoning from Residential Multifamily Mid Rise/Medium High Density District ("RMM-25") to Northwest Regional Activity Center–Mixed Use East District ("NWRAC-MUe"), the following lands, situated in the City of Fort Lauderdale, Broward County, Florida, to wit:

ALL OF LOTS 12 THROUGH 19 INCLUSIVE AND LOTS 30 THROUGH 41 INCLUSIVE, BLOCK 261, "PROGRESSO" ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 2, PAGE 18, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA

Location: South of Northwest 9<sup>th</sup> Street, east of Northwest 3<sup>rd</sup> Avenue, west of Northwest 2<sup>nd</sup> Avenue and north of Northwest 8<sup>th</sup> Street

Also depicted in Exhibit "A" attached hereto and made a part hereof.

<u>SECTION 3</u>. That the appropriate City officials of the City of Fort Lauderdale shall indicate such zoning upon a copy of the Official Zoning Map and shall indicate an amendment of Schedule "A" accordingly, upon the records with proper reference to this ordinance and date of passage.


