TITLE:	Soundscape and Noise Ordinance Study Presentation - (Commission Districts 1, 2, 3 and 4)

On September 9, 2021, the City Commission adopted Resolution 21-177 creating the Noise Control Advisory Committee (NCAC). The NCAC was formed to review the impact of noise on residences in the city and to make recommendations to the City Commission on the implementation of strategies to minimize the imposition of noise that provide a balanced approach to the administration and enforcement of the City's Noise Control Program in a manner that allows businesses to thrive while assuring a reasonable noise comfort level for residents.

On January 25, 2022, the City Commission approved the NCAC's recommendation to hire a consultant, and on September 22, 2022, the City Commission approved a \$128,013 agreement for Acoustic Consultant Services and Noise Analysis with Siebein Associates, Inc.

Siebein Associates, Inc. has worked closely with the NCAC and staff to complete the soundscape study using the strategic approach outlined in the Soundscape and Noise Ordinance Study Proposal (Exhibit 1). Siebein Associates, Inc. has prepared a Soundscape Noise Ordinance Study Presentation (Exhibit 2) and a Soundscape Noise Ordinance Report (Exhibit 3) which includes the findings of their study, proposes strategies to adopt standards for measuring sound, and offers strategies for detecting and enforcing violations of reasonable maximum permissible sound limits.
