RE: Public Participation Meeting Summary for Holiday Park YMCA and Broward Health Site Plan and Right-of-Way Vacation (DRC Case Nos. UDP-S24057 and UDP-V24001) ("Project")

Dear Ms. Tappen:

Pursuant to City Ordinance No. C-24-37, the agent for the applicant held a public participation meeting to present the Project. The meeting was conducted via Zoom on January 16, 2025, at 6:00 p.m. Notice of the meeting was mailed to all property owners within 300 feet of the Project, providing the date, time, and link to access the meeting. Additionally, notice was sent to Phil Dunlap, President of the Flagler Village Civic Association, and Melissa Carbonell, President of the Victoria Park Civic Association, as both neighborhood associations are located within 300 feet of the Project.

A total of eight (8) people attended the meeting. The applicant's agent began the presentation with an aerial overview of the property and the Project, explaining its scope and highlighting the partnership between Broward Health and the YMCA. The presentation covered the location of parking, street renderings depicting landscaping and fence screening as viewed from North Federal Highway, and detailed the site plan, layout, and functionality of the YMCA and Broward Health facilities. The agent also addressed the proposed right-of-way vacation of NE 6th Terrace as part of the Project.

The presentation concluded at approximately 6:15 p.m., after which the agent opened the floor for questions and comments. Attendees expressed satisfaction with the aesthetics of the Project. One question was raised regarding the Project's potential coordination with LauderTrail. After addressing this inquiry and the proposed right-of-way vacation, along with other comments, the agent concluded the meeting.
