Mayor Trantalis opened the public hearing.

Mayor Trantalis recognized John Batson, 208 City View Drive. Mr. Batson commented on his support of this Agenda item and inquired about related details.

Mayor Trantalis remarked on concerns related to the building height and the recently adopted transition zone Ordinance.

Mayor Trantalis recognized Robert Lochrie, Esq., Lochrie and Chakas, P.A. Mr. Lochrie explained the project's details. The project exceeds parking requirements, and there is more than one (1) parking space per unit. Though the development is adjacent to a transition zone on the north, it is in the downtown core, which does not have a height limit. Mr. Lochrie expounded on details related to the project, its location, alternative design standard, and meeting Code requirements. Further comment and discussion ensued.

In response to Mayor Trantalis' question, Mr. Lochrie confirmed the rendering included in the backup information reflects how the tower will look on the south side. Further comment and discussion ensued.

In response to Mayor Trantalis' question regarding adhering to the transition zone Ordinance, Mr. Lochrie remarked on the need to consider each project on a case-by-case basis.

Each Commission Member disclosed verbal communications, written communications, site visits and expert opinions received.

Commissioner Moraitis remarked on the importance of housing near mass transportation and support of this alternative project design.

Commissioner Glassman confirmed his support of this project, its meeting requirements of the Downtown Master Plan, and remarked on Staff driven project improvements over the previously proposed project

In response to Vice Mayor Sorensen's question, Mr. Lochrie remarked on his perspective that this project would provide workforce housing for those working in downtown and a willingness to provide first opportunities to first responders.

In response to Mayor Trantalis' question, Mr. Lochrie confirmed this project is market-rate housing.

Commissioner Moraitis commented on the need for incentives for additional housing units

Mayor Trantalis acknowledged the impact of additional housing units leveling off housing costs. He discussed his perspective regarding the importance of adhering to transition zone requirements when approving projects to prevent negative impacts on existing residential neighborhoods and the need for consistency. Further comment and discussion ensued.

In response to Vice Mayor Sorensen's question, City Manager Chavarria said he was not aware of other municipalities that accommodate housing needs for first responders. Mayor Trantalis noted his understanding that other municipalities offer this accommodation. Commissioner Moraitis remarked on an alternative to provide first responders with a housing voucher and related State legislation. Mayor Trantalis pointed out the State's preemption of imposing restrictions upon developer profits.

There being no one else wishing to speak on this item, Commissioner Glassman made a motion to close the public hearing, which was seconded by Vice Mayor Sorensen. Roll call showed: AYES: Vice Mayor Sorensen, Commissioner Moraitis, Commissioner Glassman, and Mayor Trantalis.

Resolution Accepting the Affordable Housing Advisory Committee's (AHAC) 2022 Affordable Housing Incentive Report and Authorizing the Submission to the Florida Housing Finance Corporation-(Commission Districts 1, 2, 3 and 4)

Mayor Trantalis remarked on his opposition to a reduction in parking requirements as part of this incentive program.

Commissioner Moraitis remarked on her viewpoint regarding the reasonableness of parking reductions for development projects near transportation hubs.

Mayor Trantalis expounded on details included in the Affordable Housing Advisory Committee's (AHAC) recommendations listed on page five (5) of Exhibit 2, AHAC's 2022 Affordable Housing Incentives Report. He remarked on the adverse impact of parking reductions in residential neighborhoods already experiencing that concern.

In response to Vice Mayor Sorensen's question, Mayor Trantalis confirmed he was the only AHAC member who opposed parking reductions. Further comment and discussion ensued.

Chris Cooper, Development Services Department Director, clarified that one (1) parking space per unit for an affordable multifamily dwelling is the standard in the Code and confirmed that an affordable housing developer could seek a parking reduction. Mayor Trantalis confirmed his opposition and cited related feedback from residents in Flagler Village.

Anthony Fajardo, Assistant City Manager, explained allowances that could be considered for a parking reduction request, which would go through an administrative process. He explained related considerations, i.e., close to transit or other alternatives such as off-site parking.

In response to Mayor Trantalis' question, Mr. Fajardo confirmed the administrative process only applies in Community Redevelopment Agency (CRA) area. In other areas of the City, the process must go through the Planning and Zoning Board (P&Z Board) process.

Mayor Trantalis remarked on details related to parking needs in Flagler Village.

Mr. Fajardo explained the purpose of this Agenda item is to adopt the AHAC Incentive Report, and said that the related Ordinance is not being modified.

Commissioner Glassman remarked on his perspective that the AHAC's

recommendations are incentives to make it easier to provide affordable housing.

Mayor Trantalis remarked on the impact of the Commission providing parking reduction incentives to developers in Flagler Village and Progresso Village. Commissioner Glassman remarked on input from younger residents in Flagler Village. Further comment and discussion ensued.

Commissioner Moraitis remarked on opposition to any future Commission decision that allows Accessory Dwelling Units (ADUs) to be used for vacation rental purposes. Mayor Trantalis explained that the State legislature does not allow the City to prevent the use of ADUs for vacation rentals. He remarked on the City's responsibility to make up the difference should it limit developer profitability by more than fifteen percent (15%).

In response to Vice Mayor Sorensen's question, City Manager Chavarria explained the purpose of this Agenda item communicates feedback to the Florida Housing Finance Corporation. Any related ordinance in the future would come before the Commission.

Vice Mayor Sorensen introduced this Resolution which was read by title only.

Mayor Trantalis recognized Mary Fertig, 511 Poinciana Drive, on behalf of the Idlewyld Improvement Association. Ms. Fertig requested this Agenda item be deferred to allow review and input from the community and cited examples of related questions.

In response to Mayor Trantalis' request, City Attorney Boileau explained details related to this Agenda item. The applicant hired a new architect to provide a new conceptual site plan (new CSP) rendering, and was added as an additional exhibit to the master lease. These items will proceed through the site plan approval process. He commented on examples of building reconfigurations in the new CSP, allowing for resident parking, and remarked on additional aspects and details related to the project moving forward. Core components, density, and the number of units included in the master lease will not change.

In response to Mayor Trantalis' questions, Mr. Lochrie confirmed City Attorney Boileau's comments regarding the new CSP that deletes one of the buildings and shrinks the envelope of the construction area. The changes in the master lease affect those potential changes and cleanup items.

Mayor Trantalis remarked on changes to the traffic pattern, opening of areas to accommodate The Boat Show and reconfiguring the hotel and residential building to the west.

Mr. Lochrie noted the new CSP would go through a robust public participation process and Commission review as the landlord and the regulatory agency. This Agenda item allows the developer to begin the process when and if they choose.

In response to Commissioner Glassman's questions regarding this Agenda item, City Attorney Boileau reiterated that a new architect was hired and made changes to the previously proposed conceptual site plan. The applicant approached the City and suggested cleaning up the language to accommodate the new CSP. This Agenda item does not change any language in the agreements related to The Boat Show.

In response to Commissioner Glassman's questions, Mr. Lochrie explained changes and details related to the new CSP addressing previous Boat Show concerns. Changes include the elimination of overhangs that previously impeded air-conditioning flow in the Boat Show areas and the new podiums that do not hinder the Boat Show's space. Mr. Lochrie expounded on additional details of the new CSP.

In response to Commissioner Glassman's question regarding air rights terminology discussed at the District 2 Pre-Agenda Meeting, Mr. Lochrie explained the concept of air rights. Anything built above the podium is part of air rights. City Attorney Boileau said that air rights are already in place and are a component of the phased leases and cited examples. Vertical development requires air rights for ownership interests subject to the underlying lease of the building podium that sits on land owned by the City.

In response to Commissioner Glassman's questions, City Attorney Boileau confirmed the structure of what was previously approved by the Commission remains the same. Commissioner Glassman said that the public would have ample opportunity to provide feedback as this process progresses.

In response to Vice Mayor Sorensen's question, regarding his understanding of the history related to the development application and items discussed, City Attorney Boileau said this Agenda item allows the applicant to amend and provide an additional conceptual site plan alternative for the project. Should the Commission not take action on this Agenda item, the site plan previously proposed would remain in place.

Vice Mayor Sorensen remarked on the need for the applicant and representatives from The Boat Show to communicate and requested input from representatives of The Boat Show. City Attorney Boileau remarked on related ongoing litigation.

Stephanie Toothaker, Esq., on behalf of The Boat Show, said that The Boat Show was not approached by the applicant and no one from The Boat Show had knowledge of this Agenda item coming forward.

In response to Commissioner Glassman's questions, Ms. Toothaker explained that The Boat Show had not reviewed the new CSP to determine whether it benefits or hinders The Boat Show's operations.

City Attorney Boileau explained the air rights do not affect the master lease, only the phased leases, and will not affect the Boat Show.

In response to Commissioner Glassman's question regarding feedback related to this Agenda item, Ms. Toothaker remarked on the need for a greater understanding of the new CSP included with this Agenda item. She explained concerns of The Boat Show regarding the Commission approving the new CSP as part of a lease amendment should it not be in the best interest of The Boat Show.

In response to Commissioner Glassman's question regarding the Commission being bound to the new CSP as it moves through the regulatory process, City Attorney Boileau confirmed and remarked on related details. The Commission has the ability to disapprove the ultimate site plan.

City Attorney Boileau explained the dual roles of the Commission as the proprietor and regulatory agency. Once the Commission approves the new CSP's general concept as proprietor, followed by the regulatory process approval adhering to all Code requirements, little discretion remains. He expounded on details and cited examples.

In response to Mayor Trantalis' question about approving this Agenda item without the new CSP, City Attorney Boileau advised against that because of technical changes made to the lease that correlate to the new CSP. Further comment and discussion ensued.

Commissioner Glassman discussed his review of documentation included with this Agenda item and his comfort level that it is not detrimental to The Boat Show. Ms. Toothaker remarked on the benefits of allowing representatives of The Boat Show to be included in a review of the new CSP.

In response to Mayor Trantalis' question, Ms. Toothaker confirmed the position of The Boat Show that they would like to meet with the applicant before the Commission moves forward and confirmed her preference to defer this Agenda item.

City Attorney Boileau confirmed requirements contained in the lease relating to The Boat Show with which the lessee must comply. Further comment and discussion ensued.

In response to Vice Mayor Sorensen's questions, City Attorney Boileau confirmed this Agenda item comports with ministerial changes in related documents and commented on related details. There is insufficient detail in a conceptual site plan to allow a Staff review of the new CSP and provide general feedback. Further comment and discussion ensued.

Vice Mayor Sorensen confirmed his support of The Boat Show representatives meeting with the applicant to ensure the needs of The Boat Show are met.

In response to Vice Mayor Sorensen's questions regarding air rights, City Attorney Boileau explained this only comes into play when a private entity is building condominium residences on public land where the City cedes air rights to the developer. Further comment and discussion ensued.

Mayor Trantalis commented on his understanding of Vice Mayor Sorensen's comments. City Attorney Boileau explained that waiting to approve the amendments and the new CSP would keep the previously approved conceptual site plan in place. He remarked on cost risks to the applicant for work associated with developing an unapproved site plan for the new CSP. Mr. Lochrie remarked on the need for Commission approval to begin the process and discussed the new CSP.

In response to Commissioner Glassman's questions, Mr. Lochrie reiterated the purpose of approving this Agenda item. Document language is being cleaned up to be consistent with the related proposed lease and allows the alternative new CSP and modifications discussed. Further comment and discussion ensued.

Commissioner Glassman confirmed his support of moving forward. Mayor Trantalis requested the applicant start communicating with The Boat Show and include The Boat Show in the planning process.

Commissioner Glassman introduced this Resolution which was read by title only.

Mayor Trantalis recognized Mazen Salleh, 525 N. Fort Lauderdale Beach Boulevard, on behalf of the Four Seasons Hotel and Residences. Mr. Salleh spoke in support of this Agenda item.

In response to Commissioner Moraitis' questions, Mr. Salleh explained the rental location of beach chairs for members of the public provided by Boucher Brothers. This service is limited to existing chairs currently available. Further comment and discussion ensued.

In response to Commissioner Moraitis' question regarding the timeframe for this service on the beach, City Attorney Boileau confirmed the timeframe would be determined between the First and Second Reading, either commensurate with beach operating hours or at the discretion of the Commission. Further comment and discussion ensued.

This form is for use by any person serving at the county, city, or other local level of government on an appointed or elected board, gouncil, commission, authority, or committee. It applies to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing and filing the form.

# INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which would inure to his or her special private gain or loss. Each elected or appointed local officer also MUST ABSTAIN from knowingly voting on a measure which would inure to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent, subsidiary, or sibling organization of a principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies (CRAs) under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

# **ELECTED OFFICERS:**

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; and

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

# APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the
minutes of the meeting, who will incorporate the form in the minutes. (Continued on page 2)
