TITLE: Resolution Accepting the 2025 State Housing Initiatives Partnership (SHIP)

Program Affordable Housing Incentive Strategies Report, as Prepared and Approved by the Affordable Housing Advisory Committee (AHAC) and Authorizing its Submission to the Florida Housing Finance Corporation

(FHFC) - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission adopt a resolution to accept the State Housing Initiatives Partnership (SHIP) Affordable Housing Incentive Report, as prepared and approved by the Affordable Housing Advisory Committee (AHAC), and authorize the City Manager to execute all documents associated with the submittal of the Report to the Florida Housing Finance Corporation (FHFC).

Background

The Affordable Housing Advisory Committee (AHAC) is required to annually submit an incentive report to the Florida Housing Finance Corporation (FHFC). This report evaluates the eleven (11) affordable housing incentives specified in Section 420.9076 (4) (a)-(k), Florida Statutes. To comply with this mandate, the AHAC held a duly noticed public meeting on November 10, 2025. SHIP regulations require that this public meeting be advertised to encourage public participation and Exhibit 1 confirms compliance with the notice requirement. At the meeting, the AHAC formally approved the Affordable Housing Incentive Strategies Report with its recommendations, as presented in Exhibit 2. This Report is now being submitted to the City Commission for final acceptance and approval. Upon approval, City staff will submit the report to FHFC.

Based on its evaluation of the incentives outlined in Florda Statutes, the AHAC may recommend that the local government modify, create exceptions to, or develop new plans, policies, procedures, and other governing mechanisms that would encourage the production of affordable housing. The Affordable Housing Incentive Strategies Report includes a review and AHAC's recommendations for each of the following required eleven (11) incentives:

• Expedited processing of approvals for development orders or permits for

- affordable housing projects, to a greater degree than for other projects, as provided in Section 163.3177(6)(f)3, Florida Statutes;
- Provision of all allowable fee waivers for the development or construction of affordable housing;
- Allowance of flexibility in residential densities for affordable housing;
- Reservation of infrastructure capacity for housing designated for very low-income, low-income, and moderate-income individuals;
- Support for affordable accessory residential units;
- Reduction of parking and setback requirements for affordable housing;
- Allowance of flexible lot configurations, including zero-lot-line configurations, for affordable housing;
- Modification of street requirements to accommodate affordable housing;
- Establishment of a process by which the local government evaluates, prior to adoption, any policies, procedures, ordinances, regulations, or plan provisions that may increase the cost of housing;
- Preparation of a printed inventory of locally owned public lands suitable for affordable housing; and
- Support for development near transportation hubs, major employment centers, and mixed-use developments.

City staff will utilize AHAC's recommendations in the report to make policy recommendations for new incentives and programs as well as to continue providing existing City affordable housing incentives and programs.
