- <u>SECTION 2</u>. That the City Clerk shall cause this resolution to be published once in the official newspaper of the City at least three (3) days before August 15, 2023.
- <u>SECTION 3</u>. That any resolution or part of a resolution in conflict herewith be, and is hereby rescinded to the extent of such conflict.

That this Resolution shall be in full force and effect upon its adoption.
