for Revenues Received from Property Sales – (Commission District 3)

## Recommendation

Staff recommends the Community Redevelopment Agency (CRA) Board of Commissioners approve an appropriation of \$1,300,217.50 to the Northwest-Progresso-Flagler Heights (NPF) CRA Development Incentive account.

## **Background**

At the June 18, 2024 meeting, CAM #24-0601 was approved to terminate the \$3,000,000 Development Incentive Program with Avenue D'Arts FLL, LLC and remove the restrictive covenant to construct a Comfort Suites Hotel on the property. Based on the terms of the Special Warranty Deed, the CRA would receive \$920,217.50 for the unbudgeted revenues received from the property sale.

CAM #24-0475 was approved for the sale of CRA property located at 822 Sistrunk Boulevard, 824 Sistrunk Boulevard, and 541 NW 8 Avenue to Fuse 9, LLC. at a purchase price of \$380,000.

Staff recommends the appropriation of the revenues received from the sale of the properties listed above to the Development Incentive Improvement Program account.

## **Resource Impact**

There will be a positive impact to the CRA in the amount of \$1,300,217.50 (\$920,217.50 and \$380,000) for unbudgeted revenues received from the property sales that are recommended to be appropriated on the July 2, 2024 budget amendment CAM 24-0323.
