The available floor area stated above is the floor area allowed subtracted by the existing floor area (105,298 square feet - 11,608.60 square feet = 93,689 square feet). This Certificate of Eligibility serves a calculation of potential development rights for the purposes of the Transfer of Development Rights program and is not an approval of a site plan or future development.
