TITLE: Motion Accepting Florida Department of Law Enforcement Grant - \$9,550

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an agreement from the Florida Department of Law Enforcement to support the police department in investigation and enforcement of personal identification information theft and fraud.

Background

The Florida Department of Law Enforcement's Identity Theft and Fraud Grant Program was created to provide support to local law enforcement agencies in the investigation of personal identification information theft and fraud. In August 2023, the City submitted a proposal that will focus on combating cybercrimes that target the elderly. There has been an increase in criminal reports where this vulnerable population has been deceived into remitting large amounts of money via crypto currency. Economic Crimes Unit (ECU) Detectives will trace the movement of the crypto-currency and freeze the funds in an attempt to recover the assets for the victims. The grant does not require matching funds and will end on June 30, 2024.

Resource Impact

There is an anticipated positive fiscal impact to the City in the amount of \$9,550.
