TITLE: Resolution Approving Membership in the Florida Retirement System for

General Employees - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission adopt a resolution providing for all current eligible general employees who elect to participate in the Florida Retirement System ("FRS"), and all eligible general employees hired after December 31, 2020, or as soon thereafter as administratively feasible, to become members of the FRS, and authorizing the City Manager to execute any and all agreements and amendments thereto necessary for the purpose of extending FRS benefits to the City's eligible general employees.

Background

The City Commission has determined that it is in the best interest of the City for all eligible employees other than police officers and firefighters, including employees of the City of Fort Lauderdale General Employees' Retirement System, the City of Fort Lauderdale Police and Firefighters' Retirement System, and the City of Fort Lauderdale Community Redevelopment Agency, (collectively known as "general employees") to join the FRS on January 1, 2021, or as soon thereafter as administratively feasible.

The Federation of Public Employees, a Division of the National Federation of Public and Private Employees, AFL-CIO and the Teamsters Local Union No. 769, Affiliated with the International Brotherhood of Teamsters, which represent bargaining units of the City's general employees, ratified collective bargaining agreements covering the period October 1, 2019, through September 30, 2022. In accordance with the terms of these collective bargaining agreements, the City agreed to join the FRS for bargaining unit employees on October 1, 2020, or soon thereafter as administratively feasible.

The City Commission has determined that it is consistent with the policy and purpose of the City that all its general employees, except those excluded by law, shall participate in the FRS, as authorized by Chapter 121, Florida Statutes. All current eligible general employees who elect to participate shall become members of the FRS as of the effective date of the City's participation in the FRS. Additionally, all eligible general

employees hired by the City after the effective date shall be compulsory members of the FRS beginning on their date of employment.

This resolution provides for the withholding from salaries and wages of the eligible general employees of the City of Fort Lauderdale, to be made and paid over as provided by applicable State laws or regulations; further provides that the City shall appropriate and pay over employer contributions and assessments as provided by applicable State laws or regulations; and shall keep records and make reports as required by applicable State laws or regulations.

The City's decision to join FRS is irrevocable unless the State legislature allows such revocation in the future.

Resource Impact

There is a marginal fiscal impact for Fiscal Year 2021, across all funds, in the estimated amount of \$1,019,459.
